बीमारियों के अंतर्गत डेंगू बीमारी बरसात के मौसम में बढ़ने की सम्भावना होती है। जिले में अभी तक कुल 92 डेंगू पॉजेटिव मरीज सामने आ चुके हैं। डेंगू से बचने के लिए जानकारी समय पर उपचार एवं प्रतिबंधात्मक उपाय आवश्यक है। डेंगू क्या है- डेंगू डेन वायरस से फैलने वाला संचारी रोग है। जो संक्रमित मादा एडीज मच्च्छ के काटने से फैलता है यह मच्छर दिन के समय प्राय- सुबह व शाम के समय काटता हैं डेंगू का कोई टीका या दवा नहीं है अत- एडीज मच्छर

प्रस्कों के लावां का विनिधकरण ही

शरीर में डेन वायरस का संक्रमण होने के बाद डेंगू बुखार के लक्षण 5-6 दिन पश्चात प्रकट होते है। इस हेतु घबराने की जरूरत नहीं होती है इस अवस्था में रोगी को मच्छरदानी में पूर्ण आराम करने व जल उपचार (जैसे-शिकंजी, नींब पानी, ओ आर एस, नारियल पानी, ग्लुकोज इत्यादि के द्वारा शरीर में जल की पूर्ति) करने की सलाह दी जाती है।

डेंगू बीमारी के लक्षण- सामान्य प्रकार के डेंगू में तेज सिरदर्द, ऑखों के पिछे की ओर दर्द, शरीर पर लाल चकते या दाने. जोडों व पेशियों में

ऑतों से रक्त का स्त्राव होना अथवा पाए जाते है इसमें तत्काल मरीज को नजदीकी स्वास्थ्य केन्द्र पर चिकित्सक की सलाह के अनुसार उपचार लेना चाहिए।
