Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is to inform that the Company has received demand order from the Assistant Commissioner, Ghatak 1, Division-1, Range – 1, Ahmedabad, Gujarat. u/s 74 of the Central Goods and Services Tax Act, 2017 against the Company, in relation to mismatch between ITC claimed in GSTR3B and ITC reflected on GST portal for FY 2020-21. The Department has levied a total tax and penalty of Rs. 1.24 Crore each, comprising IGST of Rs. 57.03 Lakhs and CGST and SGST of Rs.33.67 Lakhs each.

The Company proposes to file an appeal against the said Order and the Company does not anticipate any material financial impact arising from the said Order.

The Order dated 7th August, 2026 has been received by the Company on 7th August, 2026 at around 6:30 p.m.
