IndiGo Shows Further Significant Operational Improvement, Progressively Restoring Network Stability

National, December 7, 2025: Following the recent operational disruptions, IndiGo confirms that we are establishing further significant and sustained improvements across our network. The first step to this was taken yesterday, today next steps have been taken on this with lesser cancellations and a higher On Time Performance. Also, cancellations were made at an earlier stage, allowing us to inform our customers timelier.

Our teams are working relentlessly to stabilize operations, and our primary focus remains on providing an enhanced travel experience for our customers. We are making very significant progress in restoring our flight schedules and strengthening our customer support systems.

- **Today, December 7 we are on track to operate over 1650 flights**, up from ~1500 yesterday
- **On Time performance 75%**, up from ~ 30% yesterday
- **Refund and Luggage** process in full action, both for direct bookings and indirect bookings
