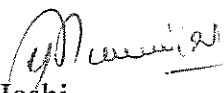
After aforesaid acquisition, the equity share holding of Welspun Promoter Group in Welspun Corp Limited stands at 94,226,005 (35.83%)

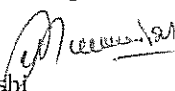
