We wish to inform you that we have received the letter under reference cited above from the promoter shareholder of the company.

In this regard we wish to state that Polaris Banyan Holding Private Limited (PBHL) (CIN U65993TN1997PTC037349) (transferor company) has been merged with M/s Aaum Holdings (India) Private limited (AHIPL) (CIN U65100TN2011PTC080320) (transferee company) vide the order of the H'ble High Court of Judicature at Madras vide its order dated 13th day of October 2015. The effective date is 18th of November 2015, being the date on which the order of the court was filed with the Registrar of Companies, Tamil Nadu.

As per the scheme, the entire business and all the movable and immovable properties, Sundry debtors, loans and advances, cash and Bank balances, etc., of the transferor company (Polaris Banyan Holding) shall be transferred to and vested in and/ or deemed to be transferred to and vested in the transferee company (Aaum Holdings).
