**Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Dear Sir/Ma'am,

This is in furtherance to the mandatory disclosure made on July 17, 2025, under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 by Jagran Prakashan Limited ("**JPL**" / "**Company**").

Please note that the matter titled "*Mahendra Mohan Gupta & Ors. v. Devendra Mohan Gupta & Ors., C.P. No. 64 of 2023*" along with all accompanying applications was listed on 08.09.2025 at 2:30 p.m. before the Hon'ble National Company Law Tribunal, Allahabad ("**Hon'ble NCLT**").

It may be noted that when the matter was taken up, the Senior Counsel representing Respondent No. 12 sought an adjournment in the matter for commencing his final arguments.

JPL was also represented by a Senior Counsel on the said date. The Senior Counsel appeared on behalf of JPL and apprised the Hon'ble NCLT that an affidavit has been filed by JPL bringing on record certain developments and re-iterating its request for *inter-alia* the reliefs sought in C.A. No. 47 of 2023.

The Senior Counsel representing the Company informed the Hon'ble NCLT that the affidavit has not come on record and requested for a date to be fixed for hearing C.A. No. 47 of 2023. However, the Hon'ble NCLT indicated that it is inclined to hear the final submissions in the matter. Upon submission by the Senior Counsel for the Company that an opportunity may be given to the other Respondents to file their replies to the Affidavit, the Hon'ble NCLT indicated that the requirement to file replies will be considered once the Affidavit is on record.

The adjournment request made by the Senior Counsel representing Respondent No. 12 was allowed, and the matter has been next listed on **24.09.2025 at 2:30 p.m.**
