Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in furtherance to the disclosure made on 23.09.2025 under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 by Jagran Prakashan Limited (“JPL” / “Company”).

Please note that C.P. No. 57 of 2025 titled “*Shailendra Mohan Gupta and Ors. v. Jagran Media Network Investment Private Limited and Ors.*”, citing instances of alleged oppression and mismanagement, was listed yesterday i.e., 17.10.2025, before the Hon’ble NCLT, Allahabad.

As disclosed earlier, Jagran Media Network Investment Private Limited (holding company of JPL) and JPL have been impleaded as Respondents No. 1 and 2 in the Company Petition. The other members of the Promoter and Promoter Group (i.e., Gupta Family members) have also been impleaded as Respondents No. 3-19. Registrar of Companies, Kanpur has been impleaded as Respondent No. 20.

The Hon’ble NCLT, after arguments, directed issuance of notice in C.P. No. 57 of 2025, and tagged the said petition with C.P. No. 64 of 2023 (filed by Mr. Mahendra Mohan Gupta, Shailesh Gupta and VRSM Enterprises LLP). Both matters are next listed on 03.11.2025 at 3:00 p.m. The Hon’ble NCLT has also directed that reply, if any, be filed by the Respondents in C.P. No. 57 of 2025, preferably within a period of two weeks.

A copy of the order dated 17.10.2025 (uploaded yesterday) is attached herewith.

Please note that we shall next provide a disclosure/update when there is a material development in the proceedings.
