Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in furtherance to the disclosure made on 27th February, 2026, under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 by Jagran Prakashan Limited ("JPL" / "Company").

The Company Petitions titled "*Mahendra Mohan Gupta and Ors v. Devendra Mohan Gupta and Ors., C.P. No. 64 of 2023*", and "*Shailendra Mohan Gupta and Ors v. Jagran Media Network Investment Private Limited and Ors., C.P. No. 57 of 2025*", along with C.A. Nos. 04, 05 and 06 of 2026 filed in C.P. No. 64 of 2023 were listed today i.e., 19th March, 2026, before the Hon'ble NCLT, Allahabad. After hearing the parties, the Hon'ble NCLT, Allahabad reserved orders in the three applications and has directed that the proposed Extra-ordinary general meeting of JPL, requisitioned by Jagran Media Network Investment Private Limited ("JMNIPL"), holding company of JPL, seeking removal of 7 Independent Directors, and 1 director from the office of WTD, be deferred for the time being, and the said requisition, be kept in abeyance, till disposal of the said company applications.

The main Company Petitions, i.e., C.P. No. 64 of 2023 and C.P. No. 57 of 2025, have been listed on 16th April, 2026 at 2:30 p.m. for further hearing.

The above is subject to a signed copy of the order passed by the Hon'ble NCLT, which shall also be shared once the same is uploaded.

Please note that we shall next provide a disclosure/update when there is a material development in the proceedings.
