1. On previous occasions, this matter had been taken up for arguments. Prior thereto, there was some serious and genuine talks for negotiations *interse* between the parties. It is now an admitted case on behalf of all the parties that the settlement somehow has not matured, and therefore the matter has now been taken up for further arguments.
2. Ld. Sr. Counsel, Dr. Abhishek Manu Singhvi representing the respondent nos.2 and 5 has commenced his arguments.
3. Meanwhile, Ld. Sr. Counsel, Sh. P. Chidambaram has also pressed that CA No.47/2023, which had earlier been filed seeking to appoint an Administrator in view of the circumstances prevailing in the company, may also be heard at this stage.
4. Dr. Singhvi however opposed the same vehemently. Be that as it may, while we see that this application is pending since 2023 along with several other applications because of the settlement talks, which had been underway,
