**Sub.: Disclosure under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015**

This is in furtherance to the disclosure made on 20<sup>th</sup> February, 2026, under Regulations 30(3), 30(4) read with Para B, Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements), 2015 by Jagran Prakashan Limited (“JPL” / “Company”).

As informed earlier, the Company has, after obtaining legal advice, filed an application in the pending matter titled "*Mahendra Mohan Gupta and Ors. v. Devendra Mohan Gupta and Ors., C.P. No. 64 of 2023*" seeking reliefs *qua* the Special Notice and the request to convene an extra-ordinary general meeting of the Company, dated 12.02.2026, proposing removal of 7 Independent Directors and of one director from the office of Whole-Time Director. This application has been numbered as C.A. No. 05 of 2026 and was listed on 24.02.2026.

Additionally, two new applications, namely C.A. No. 04 of 2026 (filed by Jagran Media Network Investment Private Limited (“JMNIPL”)) and C.A. No. 06 of 2026 (filed by Mr. Dhirendra Mohan Gupta and Mr. Sanjay Gupta) have also been filed in C.P. No. 64 of 2023 and were listed on 24.02.2026 along with C.A. No. 05 of 2026. By way of C.A. No. 04 of 2026, JMNIPL has *inter-alia* prayed that, voting in the shareholders meeting of JPL shall be carried out strictly in terms of the Board Resolution dated 14.07.2023 (of JMNIPL), and only by a person so authorized and by no other person.

In C.A. No. 06 of 2026 as well, similar reliefs pertaining to the resolution dated 14.07.2023 have been sought.

On 24.02.2026, the Hon'ble NCLT, Allahabad directed issuance of notice in the three applications i.e., C.A. No. 04, 05 and 06 of 2026. It was also directed that responses, if any, be filed within a period of two days, and the applications were adjourned for hearing on 26.02.2026 at 10:30 a.m. Additionally, the Senior Counsel appearing on behalf of the Respondents in the main Company Petition i.e., C.P. No. 64 of 2023 continued with final submissions in the matter, and it was directed that further arguments may continue on 26.02.2026.

C.P. No. 57 of 2025 titled, "*Shailendra Mohan Gupta and Ors. v. Jagran Media Network Investment Private Limited*" was also listed on 24.02.2026, and the same was also posted to 26.02.2026.

Copies of the orders dated 24.02.2026 passed by the Hon'ble NCLT (uploaded today morning) are attached herewith.

It may be noted that C.A. No. 4, 5 and 6 of 2026 were argued at length today i.e., 26.02.2026, pursuant to which the Hon'ble NCLT has reserved orders in the three applications. The applications are listed tomorrow (i.e., 27.02.2026) at 12:30 p.m. for pronouncement.

Please note that we shall next provide a disclosure/update when there is a material development in the proceedings.
