Pursuant to the provisions of Regulation 30 read with sub-para 20, para- A part A of Schedule III of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 (Listing Regulations), we hereby inform you that Company has received on 29 December, 2025 an order from the Office of the Deputy Commissioner of State Tax (SGST), Gurugram (East), Government of Haryana demanding Tax of INR-84,89,301/- along with Interest of INR- 58,60,495/- and penalty of INR-8,48,930/- .

The Company will be filing an appeal against the aforesaid Order before the concerned Appellate Authority along with the pre-deposit for stay of the demand.

We do not anticipate any material impact on the financials, operations or other activities of the Company.
