Further the Plant is expected to be operational by 31st March 2026 and will be located at the land situated at Village-Thelkadih, Dist - Khairagrah, Chhattisgarh. The approximate Project cost will be Rs. 18.00 Cr. (Rupees Eighteen Crores Only) and will be met by the Company from internal accruals and current banking facilities.
