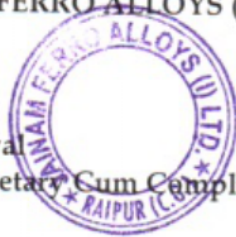

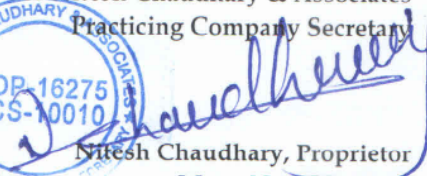
Subject: Certificate of Non-Applicability of Corporate Governance
