या संपूर्ण प्रकरणाच्या तपासासाठी विशेष तपास पथक (एसआयटी) राम मंदिर परिसरात दाखल झाले असून, चौकशी अधिक तीव्र करण्यात आली आहे. देणगी मोजणी प्रक्रिया, आर्थिक नोंदी आणि कर्मचाऱ्यांच्या नियुक्त्यांमध्ये अनियमितता झाल्याचा संशय व्यक्त केला जात आहे. एसआयटीकडून संबंधित कागदपत्रांची तपासणी आणि विविध कर्मचाऱ्यांची चौकशी सुरू आहे.



२ कोटींची रक्कम जप्त

टेलिग्राम बंदीबाबत निकाल दिल्ली हायकोर्टने राखून ठेवला

केंद्र सरकारने १६ जून रोजी घेतलेल्या निर्णयानुसार, नीट टिस्टेट २१ जूनपर्यंत टेलिग्राम सेवा भारतात तात्पुरती बंद करण्यात आली आहे. परीक्षेशी संबंधित गैरप्रकार, लीक प्रश्नपत्रिका आणि संशयास्पद चॅनेल्सच्या वापरामुळे कायदा सुव्यवस्थेचा धोका निर्माण होऊ शकतो, असा सरकारचा दावा आहे.सुनावणीदरम्यान सॉलिसिटर

जनरल तुषार मेहता यांनी न्यायालयात सांगितले की, टेलिग्रामकडून वारंवार सीईओ संशयास्पद आणि बेकायदेशीर चॅनेल्सवर नियंत्रण ठेवण्यासाठी पुरेशी सक्रिय कारवाई करण्यात आलेली नाही. 'सुमारे 22 लाख विद्यार्थी परीक्षा देणार असून, परिस्थिती बिघडल्यास कायदा-सुव्यवस्थेचा गंभीर प्रश्न निर्माण होऊ शकतो,' असा युक्तिवाद त्यांनी केला.

युकेरनेने रशियावर डागले हजार ड्रोन

मॉस्को/कीव्ह : वृत्तसंस्था
रशिया-युक्रेन युद्धाला नवे वळण देत युक्रेनने गुरुवारी रशियावर आतापर्यंतचा सर्वात मोठा ड्रोन हल्ला चढविला. रशियाच्या संरक्षण मंत्रालयानुसार रात्रभरात युक्रेनकडून डागण्यात आलेले सुमारे १,००० ड्रोन आणि चार कूड क्षेत्रणांमध्ये पाडण्यात आली. यापैकी जवळपास २०० ड्रोन रशियाची राजधानी मॉस्कोच्या दिशेने डागली होती.

युक्रेन जळत असेल तर रशियाही जळेल : झेलेन्स्की
युक्रेनचे राष्ट्राध्यक्ष वोल्दोमिर झेलेन्स्की यांनी या हल्ल्याची जबाबदारी स्वीकारत तो कीव्हवरील रशियन हल्ल्यांना दिलेले प्रत्युत्तर असल्याचे म्हटले. "युक्रेन जळत असेल तर मॉस्कोही जळेल," असे विधान करत त्यांनी रशियाच्या युद्धयंत्रणेला पाठबळ देणाऱ्या ठिकाणांना लक्ष्य करण्यात आल्याचे स्पष्ट केले. तसेच युद्ध संपण्यासाठी रशियाने आता राजनैतिक मार्ग स्वीकारावा, असे आवाहनही त्यांनी केले.

अमेरिका-इराणमध्ये युद्धबंदी करारावर स्वाक्षरी झाल्यानंतर होर्मुझची सामुद्रधुनी खुली झाली आहे. सौदी अरेबियाचा ध्वज असलेली तीन जहाजे ६० लाख बॅरल कच्चे तेल घेऊन होर्मुझमार्गे आशियाकडे निघाली आहेत. तसेच, युद्धामुळे अडकलेले ३१ सुपर टँकरदेखील रवाना होण्यासाठी सज्ज झाले आहेत. सिंगल होर्मुझचा आकडेवारीनुसार, या जहाजांची सुमारे ६.२ कोटी बॅरल कच्चे तेल वाहून नेण्याची क्षमता आहे. काही जहाजे त्यांचे स्टॅलाइट ट्रान्सपॉन्डर्स बंद करण्याची शक्यता असल्याने, खरी संख्या याहूनही अधिक असू शकते. हे तेल भारतात पोहोचाल्या सुमारे एक सप्ताह, तर पूर्व आशियात पोहोचाल्या तीन सप्ताह लागतील.
