The above information is being issued for the information and benefit of all the members of the Company and is in compliance with the MCA Circulars and the SEBI Circulars issued from time to time.

#### Tax on Dividend:

Members may note that the Income Tax Act, 1961 (Act), as amended by the Finance Act, 2020, mandates that dividends paid or distributed by a Company after 1<sup>st</sup> April, 2020 shall be taxable in the hands of the Members. The Company shall therefore be required to deduct Tax at Source (TDS) at the time of making payment of the final dividend. In order to enable the Company to determine the appropriate TDS rate, as applicable, Members are requested to submit the documents in accordance with the provisions of the Act.

- For Resident Members, tax shall be deducted at source under Section 194 of the Act at 10% on the amount of Dividend declared and paid by the Company during FY 2025-26, subject to PAN details being registered/updated by the Member. If PAN is not registered/updated in the demat account folio as on the cut-off date, TDS would be deducted @20% per Section 206AA of the Act.
- However, no tax at source is required to be deducted, if aggregate dividend paid or likely to be paid during the FY to individual member does not exceed 10,000, subject to Member not being a "Specified Person" and the status of the PAN of the Member net being "in-operative" or Record Date as per provisions of the Act. Specified Person, as defined in Section 206AB of the Act briefly means "a person who has not filed the return of income for the immediately preceding financial year i.e. FY 2023-24 or on or before the time limit prescribed under sub-section (1) of Section 139 of the Act, and the aggregate of tax deducted at source and tax collected at source in this case is Rs.50,000/- (Rupees Fifty Thousand only) or more in that immediately preceding financial year."
- In case of individual shareholders, who are mandatorily required to have their PAN-Aadhaar linked and have not done so, their PAN would be considered as "inactive." In cases where the Member submits Form 15G (applicable to any person other than a Company or a Firm) / Form 15H (applicable to an individual above the age of 60 years), provided that the eligibility conditions are being met, no tax at source shall be deducted, subject to the PAN of the Member not having an "in-operative" status as per provisions of section 139AA of the Act. TDS would be deducted @20% as per Section 206AA of the Act.
- Apart from the above, since the TDS / Withholding rates are different for resident and Non-resident Members, if there is a change in the residential status as per the provisions of the Act, Members are requested to get their residential status updated in their demat account or the physical folio, as applicable, before the Cut-off Date.
