Dear Sir/ Madam,

JPFL Films Private Limited, material subsidiary of Jindal Poly Films Limited (hereinafter referred to as "Company") has informed to the Company today on May 21, 2025 at 3.53 p.m. that a fire accident took place at their plant situated at 28th Km Stone, Nashik Igatpuri Road NH-3, Village Mundhegaon, Taluka Igatpuri, Distt. Nashik, Maharashtra, India, since 01:00 A.M. (IST) today. The Production Operation at part of the said plant is disturbed temporarily. The cause of fire will be assessed in due course by them and are also in the process of ascertaining the actual loss caused by said accident.

The details, as required pursuant to the provisions of Regulation 30 of the SEBI (LODR) Regulations, 2015, as amended from time to time, read with SEBI Master Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 are as follows:
