Bengaluru: Two months after he assumed office, Karnataka chief minister D K Shivakumar Monday inducted 19 MLAs as ministers, taking the cabinet strength to 33, leaving one vacancy.



The cabinet expansion saw a couple of records: seven SC ministers, a first in 22 years; and no representation of Brahmin community for the first time since Karnataka's reorganisation. The final ministry composition suggests the party has balanced Rahul Gandhi's push for generational change with continuity, opting for gradual renewal rather than a complete overhaul. The social composition includes seven Lingayats, seven SCs, six Vokkaligas, five OBCs, three STs, three Muslims and one Christian. The inductees include eight first-time ministers and seven from Siddaramaiah cabinet. The swearing-in ceremony

resigns from assembly**

Cong faced rebellion, with Indri M A Yashwantraaya Patil resigning from assembly and Sagar MLA Belur Gopalakrishna announcing he would follow suit. Several aspirants expressed their anger after being overlooked for a cabinet berth. More than 15 legislators met at a senior leader's home and decided to lodge their protest. **TNN**

was delayed by an hour due to last-minute changes. Former CM Siddaramaiah, whose imprint was unmistakable in the expanded cabinet, was conspicuous by his absence at the event.

Within an hour of releasing the initial list of 20 names, the high command replaced Bhatkal MLA Mankal Vaidya with Davanagere North legislator S S Mallikarjun without giving any reasons. MLC Gayathri Shanthegowda, set to be lone woman minister, was dropped owing to a dispute over her election, which is pending before the SC.

5% of NPS subscribers,
says Sitharaman in Parl**

New Delhi: For all the noise demanding an assurance on pension, Unified Pension Scheme (UPS) for central govt employees has received low traction. Data shared with Parliament on Monday estimated the number of govt employees, including those who joined recently, at 1.81 crore on July 19 — which is 4.3% of the 27.6 lakh central govt employee subscribers of National Pension Trust at the end of June.

For long, govt employees were demanding an assurance that the pension payout be at least 50% of their last salary — something that is the norm under the old pension scheme, which was discontinued in 2004 when NPS, which has contribution from the employ-

ee, kicked in.

Several opposition-governed states stopped contributing to NPS and wanted to opt out, prompting Centre to put in place UPS from April 2025. But the response to the migration option remained tepid and the Centre to extend the date up to Nov 30, 2025.

“...govt allowed central govt employees, who opted for UPS, one-time one-way switch facility to revert to NPS,” finance minister Nirmala Sitharaman said.

Along with assured 50% pension, govt also introduced retirement gratuity and death gratuity benefit available to the family upon the death of the subscriber during service. Besides, those with 10 years of service, are eligible to assured minimum monthly payout of Rs 10,000 on retirement.

**HC backs job eligibility norms,
rejects BHMS doctors' petition**

Nagpur: The Nagpur bench of Bombay high court last month dismissed a petition by homeopathic doctors seeking eligibility for recruitment as community health officers (CHOs) under National Health Mission (NHM), holding that prescription of educational qualifications falls within the domain of govt and expert bodies and cannot ordinarily be altered through judicial review. A division bench of Justices YG Khobragade and Sushil

Ghodeswar rejected the challenge filed by Homeopathic Doctors' Association, Akola, and three BHMS practitioners who have completed certificate course in modern pharmacology (CCMP).

The petitioners had challenged NHM recruitment advertisement issued, arguing that it unlawfully excluded BHMS doctors while making BAMS, BUMS, BSc nursing and BSc community health graduates eligible. **TNN**

**Udhayanidhi's
remark on actress
at Cauvery protest
sparks controversy**

Thanjavur: Leader of opposition in Tamil Nadu assembly, Udhayanidhi Stalin courted controversy on Monday over his offensive remark, alluding to a well-known Tamil actress. While addressing a protest gathering over the Cauvery dispute, Udhayanidhi took a swipe at chief minister C Joseph Vijay, alleging that Tamil Nadu had not received a single drop of Cauvery water while the CM remained unconcerned.

The rally took a controversial turn when someone in the crowd chanted, the actress's name. Pausing his speech, Udhayanidhi, with a smirk on his face, responded with an offensive double entendre, a remark that has since sparked severe political backlash.

Taking to X, Tamil Nadu BJP spokesperson Narayanan Thirupathi said Udhayanidhi's "double meaning" remark is "disgusting, obscene, vulgar and shameful". "Even a rogue or thief who has a mother, wife, daughter would not speak so vulgarly. No mother, wife, or daughter would forgive those who speak like that," wrote the BJP leader. According to him, Udhayanidhi should be arrested for this comment. **PTI**

Flavoursing neutral alcohol isn't right in spirit, says FSSAI

New Delhi: Food Safety and Standards Authority of India (FSSAI) has said alcoholic beverage manufacturers cannot add "rum flavour" to rum or "whisky flavour" to whisky and market them as standard products, emphasising the practice misrepresents the true nature of the beverage and misleads consumers. According to FSSAI, the characteristic taste

and aroma of products such as rum and whisky should develop naturally through the base ingredients, fermentation, distillation and maturation. However, inspections found that some manufacturers were producing beverages largely from neutral alcohol, which has no characteristic flavour, and then adding identical flavouring substances to recreate the taste and aroma of rum or whisky. Such products, FSSAI said,

should instead be labelled as "Rum-flavoured spirit" or "Whisky-flavoured spirit", with the front of the pack disclosing their true nature. Based on laboratory findings, FSSAI prohibited the sale of products manufactured by units of Moan Rocky Springwater, United Spirits, INBREW Beverages and Associated Alcohol & Breweries. It also inspected Mandexi Distilleries & Breweries in Goa and issued notices to six

other manufacturers in Maharashtra. FSSAI also objected to the "7 years old blended" claim on an Old Monk XXX Rum variant, saying the product contained neutral, unmaturing spirit, while matured rum spirit accounted for less than 5%. Regulator said the issue is not representative of the entire industry, noting that manufacturers continue to produce alcoholic beverages in compliance with prescribed standards.

Govt Plans Safety Framework for Dental Implants

New Delhi: The government is considering a comprehensive national regulatory and patient safety framework for dental implants, artificial teeth and related implant systems in India.

The cabinet secretariat has written to the Department of Health Research (DHR) to take necessary actions after parliament member Ajeet Madhwarao Gopchade raised concerns over unregulated use of dental implants in the country and the absence of a uniform safety and quality framework governing their manufacture, sale, and clinical use.

Dental implants are increasingly used not only for replacing missing teeth but also in oral cancer rehabilitation, facial reconstruction and other complex medical procedures, making them long-term implantable medical devices rather than routine dental consumables, the MP noted.

Any compromise in implant material quality, sterility, biomechanical strength, implant-abutment compatibility or manufacturing precision could lead to serious complications ranging from bone loss and implant fracture to chronic infection, nerve injury, repeated reconstructive surgeries and facial deformity. Gopchade said in a note to cabinet secretariat.

Yet, there are increasing concerns over non-standardised and low-quality implant systems, unverified imported implant materials, misleading commercial advertisements and "lifetime guarantee" claims, absence of uniform implant biocompatibility standards, lack of implant traceability mechanisms, variable levels of implantology training, and the absence of national long-term monitoring and adverse-event reporting systems. Gopchade noted that countries such as the US, UK and Australia require extensive testing, traceability and practitioner standards for implantable dental devices.

He asked the government to consider constituting an expert committee to examine the feasibility of establishing a comprehensive National Dental Implant Safety and Regulatory Framework for India.

He also stressed on the need for National standards for implant biomaterials and implant-grade alloys, mandatory scientific testing for fatigue resistance, sterility, biocompatibility and corrosion safety, approval and traceability systems for implant brands and batches, among other measures.



US Finalises Details of Voluntary Tests for Cybersecurity against Advanced AI Tools

The US administration has finalised the details of voluntary cybersecurity tests to measure the hacking capabilities of the most advanced American AI models, a White House official said Monday, days after Anthropic and OpenAI disclosed that their AI tools breached other companies' systems.

US President Donald Trump's team will discuss the tests with relevant technology companies, the White House official said. Anthropic representatives were invited to a meeting about the testing on Tuesday at the White House, a source familiar with the meeting said. The Information reported on Monday that the White House also invited representatives from OpenAI and Google.



The White House official did not immediately provide details about the tests, including how results will be reported. Trump directed his team in June to write a series of tests to assess the hacking capabilities of the most advanced American AI systems.

The initiative comes amid growing scrutiny of whether increasingly capable AI models could be used to conduct or facilitate cyberattacks. Anthropic last week said some of its AI models hacked into the systems of three companies during cybersecurity tests. That disclosure followed rival OpenAI's report that one of its AI agents escaped a testing environment and hacked into the systems of the AI company Hugging Face. — Reuters

मुंबई-नासिक हाइवे के गड्डों ने ली TDRF जवान की जान

परिजनों ने अधिकारियों पर मुकदमा दर्ज करने की मांग की

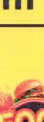

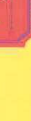
