In furtherance to our earlier communication dated 22nd May, 2023 with respect to the approval by the Hon'ble NCLT, of the Scheme of Arrangement for Amalgamation involving material subsidiary of the Company, this is to inform you that e-form INC-28 for the Scheme of Arrangement for Amalgamation of ACL Components Limited (Transferor Company 1), JMA E-Comm Private Limited (Transferor Company 2), Jullundur Auto Sales Corporation Limited (Transferor Company 3) with JMA Marketing Limited (Transferee Company) ("Scheme") was filed on 07th September, 2023 with the Registrar of Companies, NCT of Delhi and Haryana ("ROC") and the same was approved by the ROC yesterday i.e. on 31st October, 2023.

It is pertinent to note that upon effectiveness of the aforesaid Scheme, all the Transferor Companies got dissolved and consequently, the Transferor Company 3 i.e. Jullundur Auto Sales Corporation Limited, which has been appearing in the "Promoter Group" category in the shareholding pattern of the Company, holding Nil shares, will no longer exist and ceased to be a member of the Promoter Group of the Company.

It is further to submit that as Jullundur Auto Sales Corporation Limited was holding NIL shares in the Share Capital of the Company, therefore, on account of the said amalgamation there is no change in the total shareholding of Promoters and Promoter Group of the Company.
