Dear Sir,

Please refer to your trail mail/letter seeking clarification to the media report published in Times of India dated 28-09-2022 titled “Jaypee flagship company 3rd in group to face insolvency”.

In this connection we wish to submit as under:

1. We have not so far received any notice from the National Company Law Tribunal (NCLT) about filing of petition against the Company, under IBC, by State Bank of India, as reported in the captioned news item.
2. As regards the required compliances by Andhra Cement Limited and Jaypee Infratech Limited, as referred in the press report, the said companies, being listed companies must have complied with the same.
3. As regards media report regarding cancellation/restoration of Company’s lease of land under jurisdiction of Yamuna Expressway Industrial Development Authority, as already reported to the Exchanges in terms of the Company’s announcement dated 26th Feb 2020, Hon’ble High Court of Judicature at Allahabad had directed the parties to maintain status quo in terms of order dated 25th Feb 2020. The update in the matter is further reported from time to time through Quarterly / Half yearly financial results and Annual Financial Statements, as filed with the Stock Exchanges.
