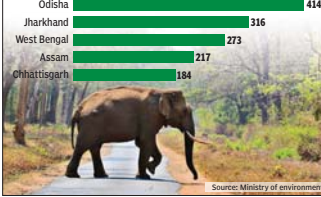

**Cheque bounce convict can make deal, avoid jail: SC**

New Delhi: A person can avoid a jail term after being convicted in a cheque bounce case if they reach a compromise with the complainant, Supreme Court said on Tuesday, holding that once a compromise deal is signed between the parties, conviction under Section 138 of the Negotiable Instruments Act cannot be sustained.

A bench of justices Aravind Kumar and Sandeep Mehta said the offence of dishonour of cheque was mainly a civil wrong and had been made specifically compoundable. "This court referred the offence under Section 138 NI Act as a Civil Wrong in Criminal Law's Clothing which meant issues agitated by the parties under the said provision are of private nature which are brought within the sweep of criminality jurisdiction in order to strengthen the credibility of the negotiable instru-

ments," the bench said while referring to an earlier verdict of the apex court. SC said when parties enter into an agreement and compound the offence, they do so to save themselves from the process of litigation. Hence, courts cannot override such compounding and impose its will, it said.

"Once the complainant has signed the compromise deed, accepting the amount in full and final settlement of the default sum, the proceedings under Section 138 of the NI Act cannot hold water; therefore, the concurrent conviction rendered by the courts below has to be set aside," SC said. "...The legislature by virtue of Section 147 of NI Act has made it compoundable notwithstanding provisions of Code of Criminal Procedure, 1973."

Hyderabad: The battle of cousins within former Telangana CM K Chandrababbarao's BRS claimed its biggest casualty Tuesday when a disciplinary committee suspended its daughter and MLC K Kavitha from the party for an unspecified period, citing her "recent attitude and anti-party activities".

The implosion, which BJP attributed to a tussle among KCR's kin for the alleged spoils of the Kaleshwaram project scam, came a day after Kavitha publicly named her father's two influential nephews—former minister Harish Rao and ex-Rajya Sabha MP Jaganapala Samra Kumar—as being involved in the alleged misdeeds of corruption. But for the duo's alleged misdeeds, Justice

**HC grants interim protection to KCR**

Telangana HC on Tuesday granted interim protection to BRS chief K Chandrababbarao and former minister T Harish Rao from "any adverse action" based on the Justice P. G. Hoskar Commission's report, until further orders, reports P. S. Sankar. The bench, comprising Justices P. S. Sankar and Justice P. S. Sankar, clarified the order would not be a final order, but only an interim protection.

She was recently removed as president of Telangana BRS. **UP man, 50, gets death penalty for rape, murder of Dalit girl in 2020**

Agra: A special SC/ST court in Mathura on Tuesday awarded the death penalty to a 50-year-old man for abducting, raping and murdering an eight-year-old Dalit girl in 2020, calling it a "rarest of rare case for its brutality".



The autopsy report revealed multiple sharp injuries to the victim's private parts, with severe damage to her uterus and internal bleeding in her kidneys and liver, which led to her death, reports Sudesh Lavania.

Additional district court counsel Subhash Chaturvedi said, "The doctor, Sonu Chaturvedi, who conducted the autopsy, also found injuries on the rectum and neck, deep bite marks on her shoulder and scratches on several parts of her body. She possibly died due to acute blood loss, as the convict, after assaulting her, strangled and left her to die in the forest at night."

On Nov 26, 2020, the Class II student was abducted while collecting firewood with a woman from her village in Mathura. Her father filed a missing person complaint when she didn't return home that evening. Police later found her body in a forested area of Vrindavan, where she had been strangled with her own clothes. The accused, a local, was arrested two days later on Nov 28.

Chaturvedi said the court of additional sessions judge Brijesh Kumar rejected the convict's plea for leniency.

**Can a person shoot himself in chest with rifle, SC asks MP**

**Raj coaching centre draft bill drops age norm**

Jaipur: The Bhajan Lal Sharma-led BJP govt in Rajasthan seems to have decided to defy Union education ministry's Jan 2024 guidelines that bar students under 16 from enrolling in coaching institutes, reports Shobh Khan. In the amended draft of Rajasthan Coaching Centre (Control and Regulation) Bill, 2025, likely to be introduced in the assembly on Wednesday, state govt has refused to impose the minimum age requirement. The revised draft bill has also relaxed penalties for violations, making it easy for erring institutes to avoid harsh punishments.

The co-accused are Athar Khan, Khalid Saifi, Mohd Saleem Khan, Shifa ur Rehman, Meeran Haider, Gulfiya Fatima and Shadab Ahmed. A different bench of Justices Subramonium Prasad and Harish Vaidya-nathan Shankar, meanwhile, rejected the bail of Taseem Ahmed, another co-accused.

Analysing the role in the alleged conspiracy of Khalid and Imam, HC said it "cannot be lightly brushed aside" while noting the duo "were the first ones to act" after the citizenship law was passed in Dec 2019 by "creating WhatsApp groups and

distributing pamphlets in Muslim-populated areas calling for protests and chakka jams, including the disruption of essential supplies".

What emerges in Imam and Khalid's role is "prima facie grave in the entire conspiracy, having delivered inflammatory speeches on communal lines to instigate mass mobilisation of members of the Muslim community," HC said, adding the duo were allegedly active participants in several violent protests, including at Jama Masjid and New Friends Colony, which involved the destruction of public property and injuries to police personnel.

**Nagpur-Kolkata IndiGo flight cancelled after mid-air bird hit**

Nagpur: A Nagpur-Kolkata IndiGo flight with 166 passengers, including former BJP MLA Shubankar Kolhe and Congress functionary Nitin Kumbhalkar, on board was cancelled after it encountered a bird strike shortly after take-off Tuesday morning. The bird-hit left a big dent on the nose of the A320neo aircraft and also damaged the weather radar. It was subsequently grounded for repairs, reports Shishir Arya.

"IndiGo flight 6E812 operating from Nagpur to Kolkata encountered a bird strike soon after take-off on Tuesday. As a precautionary step, pilots decided to turn back, and the flight landed safely at Nagpur airport. Due to requirement of necessary inspection, the flight was cancelled for the day. To minimise inconvenience to customers, we offered them refreshments, made alternate arrangements, and/or a full refund on cancellation, if opted for," the airline said in a statement.

The aircraft took off at 7.01am from Nagpur's Babasaheb Ambedkar International Airport and climbed to a height of 6,000ft when the captain contacted ATC and reported a suspected bird strike and vibrations in the airframe. At the time, the aircraft was about 75km away from Nagpur airport. The plane returned to the airport at 7.29am. After the aircraft touched down, engineers found a major dent on the nose.
