



Sources close to Kavitha aid she would soon decide on thether to remain a legisla-ve council member or re-

tive council member or re-sign. Speculation is rife that she might launch a party. Telangana BJP chief N Ramchander Rao said Kavith-Ramchander Rao said Kavith-a's remarks against her own party reflected a family feud over "ill-gotten wealth". Con-gress said her suspension after an outburst against her own was proof of wrongdoing in the Kaleshwaram case.

UP man, 50, gets death penalty for rape, murder of Dalit girl in 2020

Agra: A special SC/ST court in Mathura on Tuesday awarded the death penalty to a 50-year-old man for abducting, raping and murdering an eight-year-old Dalit girl in 2020, calling it a "rarest of rare case for its brutality". The autopsy report revealed multiple sharp injuries to the victim's private parts, with severe damage to her uterus and internal bleeding in her kidneys and liver, which led to her death, reports Sudeep Lavania.
