Greetings from AI Assets Holding Ltd.

AI Assets Holding Ltd. (AIAHL) is a Special Purpose Vehicle (wholly owned by Government of India) formed for disinvestment of Air India. Government of India decided that post disinvestment of Air India the medical facilities hitherto being provided by Air India to its retirees (Cashless IPD and OPD including OPD referrals) would be provided through CGHS.

In this regard, OMs dated 15.03.2023 and 29.05.2023 issued by CGHS to all empanelled HCOs to extend Cashless IPD facilities to the AI retirees carrying valid CGHS cards are enclosed for your ready reference. CGHS will issue the referrals for OPD/hospitalisation and empanelled hospitals shall submit the bills thereof to the UTIITSL for payment. The payment will be made by AI Assets Holding Ltd through UTIITSL at same terms & conditions as applicable to CGHS beneficiaries for treatment in empanelled hospitals at CGHS rates.

To facilitate and expedite processing of the hospital bills, a portal "<https://aiahlbpa.utiitsl.com>" has been designed by UTIITSL for hospitals to upload the bills in respect of Air India retirees. UTIITSL has sent an email to your hospital giving the user id & password for login to the portal.
