# FIFA emerges richer from a World Cup full of controversies

WITH THE DUST settling on another World Cup squabble, one thing is already clear: FIFA boss Gianni Infantino is looking stronger than ever.

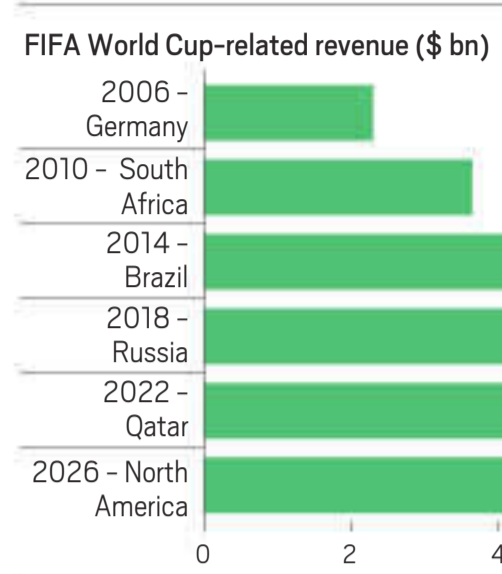
The 2026 tournament has been criticised from almost every angle, whether it be the cost of tickets, the ostracism of the Iran squad, the barring of a Somali referee or the first-ever FIFA peace prize to President Donald Trump.

Over the past few days, antipathy towards FIFA reached a fever pitch after it allowed a suspended star US player to take the field after pressure from Trump, drawing condemnation from everyone who wasn't American.

"The issue is no longer simply whether the original red card was justified," said Nick De Marco, a sports lawyer based in the UK. "It's whether FIFA has undermined the integrity of the World Cup, and its own authority as the global regulator of football."

These complaints, though, will likely fade away once the tournament has finished. Following a 4-1 thrashing of the US by Belgium, the intensity of

the controversy over US striker Folarin Balogun being allowed to play has begun to dissipate. Infantino, meanwhile, has remained resolutely focused in perhaps his most important job — generating cash.

FIFA faces constant tension over balancing proximity to power and money with its other remit, to uphold the rules and regulations of the sport. Money is winning out.

Under the 56-year-old administrator for the most lucrative sport on the planet, FIFA is expected to bring in about \$9 billion directly from the 2026 World Cup, about \$2

billion more than the 2022 edition in Qatar.

FIFA became synonymous with scandal a little over a decade ago after a corruption case pursued by US prosecutors. Within a year, Infantino was brought in as the new face of the organisation. He oversaw reform, marginally increased transparency and dramatically expanded the size and scope of FIFA's tournaments, including the lucrative Club World Cup. But he's also taken the governing body down a familiar path of mixing money, power and politics.

# Ronaldo bids farewell to World Cup

THE BIGGEST DREAM of Cristiano Ronaldo would remain unfulfilled forever. The man who guzzled most of the records and trophies that football could offer would slip into the sunset without its greatest prize, the World Cup.

It was the dream, to kiss the Cup, to cradle it like a baby. It was this wish that kept him burning at 41, that made him rise above the aches and niggles of a sculpted but battered body.

After Portugal's 0-1 loss to Spain in the Round of 16, his eyes were cold, almost numb. It was perhaps the moment he reconciled with his unfulfilled dream.

He walked without emotion, immune to the commiseration of his own men, to the handshakes and hugs of the victorious Spanish team, including the gatecrasher of his dream, Mikel Merino, the man who scored in injury time. Perhaps he was drained, or simply grieving an arena that was never his.

"I'm sad to leave the World Cup this way," Ronaldo would say after the game. "As I said yesterday, I gave it my all, and I leave with a clear conscience. That's the life of a footballer. You have to move forward."

The World Cup was never his grandest stage. The num-

bers pale — 11 goals, only one of those in a knockout, and two assists in 26 games. Fewer goals than Miroslav Klose and Harry Kane, as many goals as Sander Kocsis and Jurgen Klinsmann. His most memorable night came against Spain, eight years ago, when he slammed in a hat-trick against them in a group game.

But most days and nights in the tournament brought him pain and tears, misery and dejection. In six World Cups, the furthest he and his team progressed was in 2006. He could not inspire his country, in youth or middle age, the way he lifted club to dizzying heights.

There are other legends who were denied the sweetest taste on a football field. Even more cruelly. Like Johan Cruyff and Roberto Baggio. But he was, rather he believes he was, no ordinary legend. Ronaldo without the crown and sceptre is akin to Caesar without the Empire.

If his wish ended at the legs of Merino, it had metaphorically come to a grinding halt long ago.

The vaulting ambition he blinded the reality that he had been a burden for his teammates, as well as for his own image. He ignored his body, his

team, and the game changing around him. He was scoring goals, his fans and manager Roberto Martinez retaliated, but little else. Then the goals dried up too, the sign his time was over.

Yet he insisted, and the manager, who deserves some slack, persisted. The force, the whip and precision too have forsaken him, the tools with which he had counteracted his waning athleticism.

His 15 attempts fetched only three goals — a brace against minnows Uzbekistan and a penalty against Croatia. Against Spain, he had three shots, none of which really bothered Unai Simon. The first was his sweetest strike, but from an acute angle that Simon parried around the post. Moments earlier, he was distraught when Rodri's tug on his shirt inside the box went unpunished, even without a routine VAR check.

No player perhaps wanted to win the game quite like Ronaldo. But, perhaps, no player stood between him and his dream more than Ronaldo himself. That was the cruellest paradox in Ronaldo's last act on the stage that never loved him back.

# IOC provisionally lifts suspension on Russian Olympic Committee

THE INTERNATIONAL OLYMPIC Committee provisionally lifted its suspension of the Russian Olympic Committee on Tuesday, a step towards Russia's return to the Olympic fold ahead of the Los Angeles 2028 Games.

Following Russia's invasion of Ukraine in February 2022, the ROC was suspended in October 2023 for recognising regional

Olympic councils in Russian-occupied parts of Ukraine — Luhansk, Donetsk, Kherson and Zaporizhzhia.

The IOC said its executive board had lifted the suspension but had not decided yet on whether Russia could display its flag, colours or have its anthem played at the Games.

Russian sports minister Mikhail Degtyarev said the IOC's decision should clear the

way for Russian athletes to make a full return to the international sporting stage.

"Our country's return to the Olympic family is a green light for international federations to reinstate all our athletes," Degtyarev said.

Russian athletes competed as neutrals at the 2024 Paris Olympics and at the 2026 Milano Cortina Winter Games. — REUTERS

**SPAIN'S CLEAN SHEET** Spain achieved a historic feat by becoming the first team ever to keep six consecutive clean sheets at WCs. A late strike from Mikel Merino sunk Portugal 0-1 and handed Spain a ticket to QF. La Roja's record streak dates back to 2022.

**MBAPPE BLASTS SENATOR** French star Kylian Mbappe has condemned a Paraguayan senator over racist remarks she made following Paraguay's loss to France in the R16 at the World Cup. Mbappe called Celeste Amarilla, a "despicable woman" who was "unworthy" of serving in Paraguay's Congress. Amarilla called Mbappe a "colonised Cameroonian... pretending to be French".

**BELGIANS' 'TRIBUTE' TO TRUMP** Belgium players celebrated their 4-1 win in the R16 over hosts US with a dance inspired by US Prez Donald Trump. Following Romelu Lukaku's stoppage-time goal, the Belgians emulated the viral dance. The official Instagram account of the Iran football team also took a dig at the US with the caption, "Dance with me!".



**'SIU' AT WIMBLEDON** Italian tennis star Flavio Cobolli celebrated his Wimbledon win with the iconic 'siu' celebration on the court after his win over Marin Cilic. The crowd at the All England Club leaned into the football crossover in unison.

**FIFA HONOURS DHONI** FIFA honoured former cricketer MS Dhoni on his birthday with a post on its Instagram account. The post mentioned, "7 Goals. Thala for a reason. Happy Thala Day," paying tribute to the former captain and his iconic jersey. Incidentally, Lionel Messi, Mbappe & Erling Haaland have scored 7 goals each so far. Compiled by Ankit Pattnaik
