Details of the violation(s)/ contravention(s) committed or alleged to be committed	<p>The subsidiary company of JTEKT India Limited (JIN) known as JTEKT Sona Automotive India Limited (JSAI) has been merged with its holding company JTEKT India Limited w.e.f. 01.04.2018 vide National Company law Tribunal’s Order dated 07.03.2019.</p> <p>Show Cause Notice has been issued by Income Tax Department for the FY 2019-20 wherein the company has been show caused why the difference amount should not be added to the Income on following issues:</p> <p>(i) As per ITD’s notice, the value of Imports & Bill of entry for imports is INR 784.20 Million while as per company records such value is 55.39 Million. Thus, there is difference of INR 728.81 Million.</p> <p>(ii) As per ITD’s notice, the value of Outward Foreign Remittances is INR 31.09 Million while as per company records such value is 30.66 Million. Thus, there is difference of INR 0.43 Million.</p>
Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible	<p>The company will file a reply to the Show Cause Notice before the ITD within the prescribed timeline.</p> <p>Currently, the Show cause notice has no impact on financial, operational or other activities of the Company. Furthermore, the show cause notice which is issued by the ITD does not impose any penalties or financial fines.</p>
