**Sub: Intimation under Regulation 30(11) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations')****Ref: Clarification on news article published in mainstream and other media, and material price movement observed in Company's stock price**

This is in reference to a news article published in the "<https://www.businessworld.in/>" dated April 7, 2026 captioned "Jubilant FoodWorks Shares Drop 10% On Weak Same-store Growth, LPG Disruptions" and certain other media reports, wherein *inter alia* it has been stated that the weakness has largely been attributed to disruptions in commercial LPG supply, with more than 95 per cent of the company's outlets dependent on LPG for operations.

In this regard, the Company would like to clarify that the aforesaid percentage does not emanate from any disclosure, statement or communication made by the Company, and should not be construed as the Company's position, guidance or representation. The proportion of stores dependent on LPG for operations is lower and is progressively reducing through movement to alternate energy sources.

The Company had provided a business update regarding LPG supply constraints to certain parts of the Company's store network and informed that the operational impact is limited during Q4'FY26. In this regard, we wish to further inform that the availability of energy supply has improved over the past weeks and operations are now back to normal levels.

The Company remains confident about its core strengths and achieving its strategic objectives. On the back of strong fundamentals and a disciplined approach to execution the Company is well equipped to address short-term challenges while continuing to drive sustainable growth and creating long-term value for its shareholders.

The Company reiterates that it has been promptly disclosing all material events and information required to be disclosed under Regulation 30 of the Listing Regulations and there is no undisclosed material information or misstatement by the Company in this regard.
