 NOTICE is hereby given that the 44<sup>th</sup> Annual General Meeting ("AGM") of the Members of Jupiter Wagons Limited ("the Company") for the F.Y. 2023-24 will be held on Thursday, September 12, 2024 at 01:00 P.M. through electronic mode [video conference ("VC") or Other Audio Visual Means ("OAVM")] without the physical presence of the Members at a common venue, in compliance with all the applicable provisions of the Companies Act, 2013 and rules made thereunder and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with latest General Circular No. 09/2023 dated 25<sup>th</sup> September, 2023 issued by Ministry of Corporate Affairs read with other previous circulars issued by MCA in this regard (hereinafter collectively referred to as "MCA Circulars") and SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated 7<sup>th</sup> October, 2023 read together with other previous circulars issued by Securities and Exchange Board of India ("SEBI") (hereinafter collectively referred to as "AGM related circulars"), to transact the businesses set out in the Notice of the AGM. The requirement of sending physical copies of the Annual Report has been dispensed with.

In compliance with the said MCA circulars and SEBI Circular, the Notice of the AGM along with Annual Report for the financial year 2023-24 will only be sent, through electronic mode to all the members whose email IDs are registered with the Company/ Depository Participant(s) Company's Registrar and Share Transfer Agent (RTA) viz. KFin Technologies Limited ("KFin"). Pursuant to provisions of Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management and Administration) Rules, 2014 and Regulation 42 of Listing Regulations, the Register of Members and Share Transfer Books of the Company will remain closed from Friday, 6<sup>th</sup> September, 2024 to Thursday, 12<sup>th</sup> September, 2024 (both days inclusive) for the purpose of AGM and to ascertain the names of members who would be entitled to receive dividend, if approved at the AGM.
