आहे. निवडणुका कोणत्याही असे. त्याला राजकीय महत्वाकांक्षेचाच ठिकठिकाणी दर्द येतो. कोणालाही सामान्य माणसाच्या भल्यासाठी जनतेला दिलासा देण्यासाठी किंवा सामान्य माणसाच्या हितासाठी निवडणुक लढवायच्या नसतात. आयुष्यात एकदा तरी एखादी तरी निवडणुक जिकावी अशी महाराष्ट्रातल्या करोडे लोकांची इच्छा असते. त्यातल्या काही लाख लोकांची राजकीय महत्वाकांक्षा पूर्ण करण्यासाठी हे लोक राजकीय पक्षांच्या दावणीला स्वतःला बांधून घेतात. त्या लाखांमध्यल्या काही हजारे लोकांना निवडून आणण्याचे कंत्राट वेळेवरे राजकीय पक्ष घेत असतात म्हणजे ज्याप्रमाणे सगळ्या महापालिकांमध्ये कंत्राटांच्या अर्थकारण्यावरच राजकारणांचा सतेचा दरबार चालत असतो. त्याच महापालिका निवडणुकांमध्ये निवडून येण्याचे कंत्राट हे राजकीय पक्ष स्वतःकडे घेतात. नारसेवक पदाच्या टेंडर्साठी अर्ज भरणे म्हणजे उमेदवारी अर्ज दाखल करण्याचा प्रकर असतो. आपण कितीही असे म्हटले की, मतदार उमेदवारांना निवडून देतात पण हे अर्धस्थ ठरते. मतदारानांदेखील अमिग दाखवले जातात आणि राजकीय पक्ष अक्षरशः वाटेल ते प्रकर करून आपला उमेदवार निवडून आणत असतात. भारतात संसदीय लोकशाही व्यवस्था आहे आणि ती लोकशाही जालेनी आहे.

फसवे आणि छोरे शब्दप्रयोग

निवडणुकांसाठी वापरले जाणारे शब्दप्रयोग तितकेच फसवे आणि छोरे स्वरूपाचे असतात. रणसंग्राम, रणधुमाळी, म्हणजे यातून सौर्दृष्टता व्यक्त होण्याएवजी संवर्धलाच आमंत्रण दिले जाते. कारण निवडणुकीच्या मैदानात हे राजकीय युद्ध खेळले जाते आणि म्हणून निवडणुक लढवणे किंवा ती जिकणे, हरणे असेच शब्दप्रयोग रुढ झालेले आहेत. जर निवडणुक ही लोकशाही व्यवस्थेत निवडणुकांना कोणताही पर्याय नाही. म्हणूच निवडणुकांचे बिगुल वाजल्यावर राजकारणीदेखील स्वतःचेच ढोल बडवण्यासाठी सज्ज होतात. ज्याच्याकडे जसा पैसा आहे. माणसंगोळा करण्याची ताकद आहे किंवा सामावाम, दंड, खेद, याच्या चैपेर प्रहार करण्याची ताकद आहे. ते निवडून येण्याची जास्त शक्यता असते. विशेषतः गेल्या काही वर्षपासून महापालिका निवडणुक म्हणजे मिनी विधानसभा निवडणुकांचा झालेल्या आहेत आणि याच पद्धतीने पैसाचा आणि प्रचाराचा धुराळा उडत असतो. यातून नेमके कोणत्या लोकशाहीचे समर्थन होते. हे प्रत्यक्ष ब्रह्मेवेही सांगू शकणार नाही.

मुंबई महापालिकेची ऐतिहासिक निवडणुक

लोकशाही व्यवस्था स्वीकाराल्याने ज्या काही गोटी अनिवार्य आहेत त्या केल्याशिवाय लोकांनुद्देही पर्याय नसतो. परंतु ही व्यवस्था अधिक पारदर्शक व्हावी, लोकशाही व्यवस्थेवरच विश्वास अधिक मजबूत व्हावा यासाठी खुप मुधारण घडवून आणण्याची आवश्यकता आहे परंतु ते करण्याची किंवा तसा आग्रह धरण्याची कोणत्याही राजकीय पक्षाची किंवा नेत्याची प्रामाणिक इच्छा नसते. जर या व्यवस्थेमध्ये पारदर्शकपणा असता तर गज्यातल्या महापालिका निवडणुक इतक्या लांबल्या नसत्या. यावेळीची मुंबई महापालिकेची निवडणुक ही एकाअर्थी ऐतिहासिकच म्हणावी लागेल. यापूर्वी कधीही राज्याची राजधानी आणि देशाची आर्थिक राजधानी अमलेल्या मुंबई महानगराचा कारभार तब्बल साडेआठ वर्षे प्रशासकांच्या ताब्यात राहिला नव्हता. म्हणजे लोकशाही व्यवस्थेचा बुरुचा पांध्रून देशातील सर्वात श्रीमंत महापालिकेची
