On the above subject matter, pursuant to the provisions of Regulation 30 of SEBI Listing Regulations, we would like to inform that we have received a notice vide Rc.No. 21/2001/TO, dated 13.05.2024 from District Forest Officer, NTR Division, Vijayawada informing the Company to stop mining/non forest activities in the leased out area of 121.46 Hectares in Sy.No.236, Budawada Reserve Forest until further forest clearance.

We have initiated necessary process to get it revoked as the period shall be deemed to have been extended upto a period co-terminus with the period of mining lease i.e. 18.05.2032 as per the Circular/s of Govt of India, Ministry of Environment, Forest and Climate Change (FC Division).

There is no financial impact on the Company as the Company has sufficient Lime Stone stocks to cater to the requirements of the Company for over a period of two months.

The Company has been actively liaising with the concerned authorities and resolve the matter at the earliest.
