Dear Sir,

I, Manjula Aleti, Proprietor of M/s. Manjula Aleti & Associates, Practicing Company Secretary, having Office at H.No.5-1-100, 2nd Floor, Maheshwar Complex, Kukatpally, Hyderabad - 500072 was appointed as Scrutinizer by the Board of Directors of Kakatiya Cement Sugar & Industries Limited ("the Company") for the purpose of scrutinizing of voting process i.e. remote e-voting and voting at Annual General Meeting in pursuance of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as substituted by the Companies (Management & Administration) Rules 2015 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 on the Agenda items mentioned in the notice dated May 23, 2025 of the Annual General Meeting of the members of the Company.

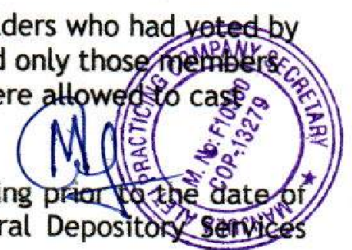
The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and rules relating to voting through remote e-voting and voting at AGM on the resolutions contained in the notice of AGM. My responsibility as a Scrutinizer is restricted to make a Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions in the agenda items as stated above based on the report generated from the e-voting platform provided by CDSL.

The Shareholders of the Company holding shares as on the "Cut -off" date of August 21, 2025 were entitled to vote through e-voting on the proposed resolutions as set out in the Notice of the Annual General Meeting.

The Company has availed the e-voting facility offered by Central Depository Services (India) Limited for conducting the e-voting by the Shareholders of the Company. The e-voting process started on Monday, August 25, 2025 at 9.00 A.M and ended on Wednesday, August 27, 2025 at 5.00 P.M.

As per the information provided by the Company, the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who were present at the AGM and who had not voted on remote e-voting were allowed to cast their votes through ballot paper during the AGM.


After closure of e-voting at the AGM, the votes cast through remote e-voting prior to the date of AGM were unblocked and downloaded from the e-voting system of Central Depository Services (India) Limited (CDSL).



I have scrutinized and reviewed the voting through remote e-voting and voting at the AGM and votes tendered therein based on the data downloaded from the e-voting system of CDSL.

I have observed that 215 Members have attended the AGM in person among them 147 Members have voted at the AGM venue and 57 Members have already casted their vote through Remote e-voting, 11 Folios founded duplicate and 133 Members have cast their votes through remote e-voting facilitated by CDSL before the date of AGM.

We, the undersigned have witnessed that the votes cast through remote e-voting were blocked from CDSLs' e-voting website <https://evotingindia.com> in our presence on August 28,2025.

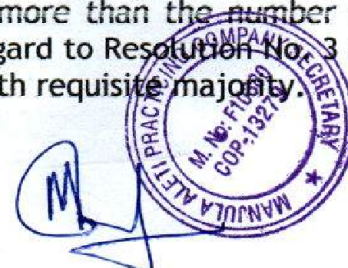

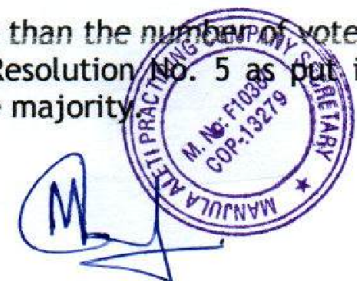
