U. penalty (non-use penalty) on account of alleged non-fulfillment of the requirement of ground coverage construction and corrigendum order passed by the Gujarat Industrial Development Corporation ("GIDC") in one application, which resulted in a reduction of penalty to Nil (which was amounting to INR 0.44 crore & applicable GST), this is to further update that GIDC has passed its second corrigendum order and consequently, the aggregate penalty has been reduced to Nil.

The corrigendum order was received by the Company on 06<sup>th</sup> December, 2025 at about 06:27 P.M. (IST). The disclosure is being submitted today being the first working day after receipt of the order.

U. penalty (non-use penalty) of INR 2.12 crores along with applicable GST on account of alleged non-fulfillment of the requirement of ground coverage construction, this is to further update that GIDC has passed its corrigendum order in one application resulting in a reduction of penalty to Nil (which was amounting to INR 0.44 crore & applicable GST), while the application for the balance amount is currently under adjudication on similar grounds.
