Dear Sir / Madam,

In terms of Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in reference to our earlier intimation dated 21st February, 2025 submitted to the stock exchanges (copy attached), wherein the GST Authority had passed an Order and had demanded to pay penalty of INR 42.80 lakhs, in addition to tax demand and interest on account of alleged grounds of wrong/excess availment of input tax credit for the F.Y. 2020-21, the Company had filed an appeal before the Appellate Authority against the said Order passed by the State GST Authority. The Hon'ble Appellate Authority vide its Order has allowed the appeal filed by the Company, resulting in a reduction of the tax demand and interest, with penalty revised to INR 0.4 lakh. The Order of the Hon'ble Appellate Authority was received by the Company on 29th August, 2025 at about 12:16 P.M. (IST). The disclosure is being submitted at the earliest possible opportunity, post conclusion of internal deliberation of the Order.
