## 'Adopt swadeshi as way of life': CM flags off Unity March in Ahmedabad

GUJARAT CHIEF MINISTER Bhupendra Patel on Monday appealed to people to adopt "swadeshi" as a way of life and commit themselves to realising the vision of Viksit Bharat 2047, as he flagged off the 'Unity March' in Ahmedabad on Monday. The Sardar@150 Unity March is being organised nationally to mark the 150th birth anniversary of Sardar Patel to spread the message of national unity. The state-wide march was launched from Junagadh on November 9.

"Remembering Sardar Patel, we should all adopt 'swadeshi' as a way of life and contribute to building Viksit Bharat. We should all unite and commit ourselves to realising the vision of Viksit Bharat @

2047," the chief minister said as he flagged off the march from his Ghatlodia assembly constituency. Addressing a gathering, he said after India's independence, Sardar Patel, as the first deputy Prime Minister and home minister, unified 562 princely states to build a united and indivisible India.

"Prime Minister Narendra Modi has realised this mantra of unity through 'Ek Bharat Shreshtha Bharat'. Both the Prime Minister and Union Home Minister Amit Shah have united India from Cuttack to Kutch and from Kashmir to Kanyakumari by removing Article 370," he said.

He said the Prime Minister has offered a true tribute to Sardar Patel by building the world's tallest statue — the 'Statue of Unity,' which stands as a powerful symbol of India's strength and its proud, illus-

trious history.

## Man who 'killed woman' on their wedding day arrested

Police tracked down Sajjan Khagna Baraiya on Sunday night, a day after the crime

THE BHAVNAGAR City Police on Sunday night arrested a man who was allegedly absconding after the murder of his bride-to-be, hours before they were to get married on Saturday.

The accused, Sajjan Khagna Baraiya (26), and Soni Himmat Rathod (22) had allegedly been in a relationship for the past one and a half years against the wishes of their families. However, police said, the families had decided to get the couple officially married.

Sajjan allegedly went to Soni's parents' home and had an altercation with her before the alleged assault which led to her death. P V K Makwana, in-charge of Gangajaliya police station, said they had finally managed to track him down and arrest him on Sunday.

A statement from the Bhavnagar Police said Sajjan is a history sheeteer and has at least six previous cases against him — two each in 2023, 2024 and 2025. The murder of Soni is now the seventh case. Previous

cases against him include charges of murder, attempt to murder, causing grievous hurt, voluntarily causing hurt, and endangering human life.

DySP RRR Singhal of Bhavnagar City Division had earlier told *The Indian Express*, "Since they were getting married, Soni had gone back to her parental home. Early on Saturday morning, Sajjan arrived there and they had an altercation regarding the panetar (bridal dress) and paisa (money). This argument escalated to the point where Sajjan allegedly took an iron pipe and hit the victim several times, causing grievous injuries. He also grabbed her head and hit it against the wall, leading to her death."

When the family woke up and rushed to the spot, they found Soni dead. They then called the police control, a team from Gangajaliya police station reached the spot and the body was sent for post mortem. An FIR was subsequently filed at Gangajaliya police station.

## Kin of 3 Surat undertrials get 'extortion calls' for mattresses, tiffin services in jail

THE FAMILY members of three men who were arrested for allegedly demanding Rs 10 crore in ransom from a builder allegedly received anonymous calls, demanding Rs 15,000 each for mattresses and home-cooked tiffin services for the inmates in jail.

The caller, who identified himself as a jailor of Surat Cen-

tral Jail, phoned the families on the afternoon of November 8 before the three were sent to judicial custody.

Acting on a ransom and life-threat complaint lodged by builder Varjang Dangar, Adajan police had arrested Smit Dholakiya, Prashant Kachhadiya and Jay Dangar, all Surat residents, a few days ago.

After the completion of their police remand, they were transferred to judicial custody

at Surat Central Jail on the evening of November 8.

On November 8, while all three accused were in the Surat district court, Sweety Dholakiya (wife of Smit), Kanji Kachhadiya (father of Prashant) and Karshan Dangar (father of Jay) allegedly received calls from the same number. The caller identified himself as a Central Jail jailor and told them they must pay Rs 15,000 each to provide facilities.

## Rajkot: Woman dies two days after husband 'shot at her, killed self'

NEARLY 48 hours after being shot three times, allegedly by her husband, Trusha Padhiyar succumbed to her injuries early Monday morning in Gujarat's Rajkot, police said.

According to police, Lalji Ramesh Padhiyar allegedly shot the victim in the head and face with his licensed pistol during an altercation on the morning of November 15, before he died by suicide. While paramedics declared Lalji dead on the spot, they found Trusha alive despite three bullet wounds. She was rushed to Rajkot Civil Hospital for emergency surgery and later shifted to a private hospital. ACP Radhika Bharai said Trusha died at 4 am on November 17. Rajkot City Police have moved court to change the charge from attempt to murder (BNS 109) to murder (BNS 103) against Lalji. As the accused is deceased, the case will eventually conclude with an abated summary, officials said.

The couple's son, who wit-

nessed the aftermath, is 18. Police said several family members have come forward to take him into their care.

The FIR, filed at Gandhinagar police station on the basis of a complaint by Trusha's brother Jay Mukesh Rathod, states that the couple had allegedly been arguing for over a month over suspicions of an extramarital relationship. Trusha had since been staying at the home of a friend, Pooja.

On the night of November 14, Lalji allegedly called Jay to his home. The two, along with the couple's son, went to Pooja's residence at 11 pm to speak with Trusha. When the discussion did not resolve matters, they returned to Lalji's home. Around 9 am, Jay was woken by calls on his nephew's phone, police said.

A neighbour informed him that Lalji and Trusha were arguing outside Pooja's building. When he reached the spot, he found Lalji lying on the ground with a pistol next to him.

Bystanders claimed Lalji fired at Trusha before shooting himself.

## MBA student found dead in room had heart attack: Police

THE VADODARA city police said on Monday a 25-year-old MBA student from Parul University, who was found dead in his rented paying guest (PG) accommodation in Fatehgunj on Saturday, had died of "heart attack". The post-mortem report

ruled out the possibility of unnatural death, police said.

Gatik Dass, a Kashmiri pandit, had been found lying motionless on his bed at his PG accommodation on Saturday, police said.

A senior police officer said, "There is no indication of foul play... The body has been handed over to his father."
