## ‘किसान आंदोलन पर भ्रामक विमर्श गढ़ रहा है पूर्व नौकरशाहों का समूह’

नई दिल्ली, 8 फरवरी (भाषा)।

सेवानिवृत्त नौकरशाहों और न्यायाधीशों के एक समूह ने सोमवार को दावा किया कि किसानों के आंदोलन को समाप्त कराने के लिए सरकार ने न्यूनतम समर्थन मूल्य (एमएसपी) के बारे में कानूनी आश्वासन देने और कृषि कानूनों को 18 महीनों के लिए निलंबित करने का एक मध्य मार्ग सुझाया है, लेकिन पूर्व नौकरशाहों का एक समूह अभी भी एक भ्रामक विमर्श गढ़ने की कोशिश कर रहा है।
