I, Shashikant Tiwari, Partner of M/s. Chandrasekaran Associates, Company Secretaries having office at 11F, Pocket IV, Mayur Vihar, Phase-I, New Delhi-110091, was appointed as Scrutinizer of M/s Kamdhenu Ventures Limited ("Company") for remote e-voting and e-voting (hereinafter referred to as the "electronic voting") at the Extra-Ordinary General Meeting ("the Meeting") convened through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM") in respect of the below mentioned resolution considered at the Meeting of the members of the Company as per notice dated June 28, 2023.

Pursuant to the General Circular No. 14/2020, 17/2020, 22/2020, 33/2020, 39/2020, 10/2021, 20/2021, 03/2022 and 11/2022 dated April 8, 2020, April 13, 2020, June 15, 2020, September 28, 2020, December 31, 2020, June 23, 2021, December 8, 2021, May 5, 2022 and December 28, 2022 respectively, issued by Ministry of Corporate Affairs ("MCA Circular") and SEBI Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, SEBI Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 dated May 13, 2022 and SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated January 5, 2023 ("SEBI Circular") (collectively referred to as the "Relevant Circulars") the Company has dispatched the Notice of 02/2023-24 EGM on June 29, 2023 by email to all those members whose email addresses were registered with the Company or with the Depository Participants or with the RTA of the Company as on the closure of the business hours of June 23, 2023.

The Company has not dispatched the Notice of the meeting to those members whose e-mail IDs were not registered/ available with the Company or with the Depository Participants or with the RTA of the Company. However, the Company has given an additional option to such members to register their e-mail ids with the Company in the Notice of EGM itself. The Notice dated June 28, 2023 convening the meeting was sent to the members on June 29, 2023 in respect of the resolution proposed to be considered at the meeting held on July 24, 2023 and also given the newspaper advertisements dated June 30, 2023 in all editions of "Financial Express" (English) and Delhi edition of "Jansatta" (Hindi) as per Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 47 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015.

The Company has appointed National Securities Depository (India) Limited ("NSDL") for providing the electronic voting facility for conducting electronic voting at AGM by the members of the Company.



The remote e-voting period commenced on Friday, July 21, 2023 at 9:00 a.m. (IST) and concluded on Sunday, July 23, 2023 at 5:00 p.m. (IST) and the NSDL e-voting platform was blocked thereafter and then reopened during the meeting and kept opened during the meeting.

Further, the e-voting was announced for the members who attended the meeting but have not cast their vote through remote e-voting.

The Members of the Company as at the closure of business hours of July 17, 2023 ("Cut-Off date") were entitled to vote on the proposed resolution as set out in the Notice of the meeting, and their voting rights as on date has been reckoned with for the purpose of arriving at the result of the e-voting for the meeting, and the company being limited by Shares, every member shall have one vote and their voting rights as on that date has been reckoned with for the purpose of arriving at the result of the electronic voting for the Meeting.



Subsequently, the remote e-voting was unblocked on July 24, 2023 around 11:55 A.M. in the presence of two witnesses i.e. Anchal Bansal R/o. A 37, Block-A, Sector-15, Noida, Uttar Pradesh- 201301 and Ms. Shweta Aneja R/o. H-44 Laxmi Nagar, Vijay Chowk Gali No. 3, Delhi 110092, who are not in the employment of the Company.

The votes cast through e-voting, which were incomplete, if any, have been treated as invalid.

The Management of the Company is responsible to ensure compliance with requirements of the Act and rules made there-under relating to electronic voting on the resolution contained in the Notice of the Meeting.

My responsibility as scrutinizer for electronic voting is restricted to making a scrutinizer report of the votes cast in favour or against the resolution.

Based on the data downloaded from the official website of NSDL i.e. evoting.nsdl.com for the electronic voting, we now submit our consolidated report thereon.
