Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and other applicable provisions, we wish to inform you that the Board of Directors of Kataria Industries Limited at its meeting held today i.e. 06/03/2026, inter alia, considered and approved modification in the effective dates and timing with respect to change in Market Maker of the Company.

The Board noted that at its meeting held on 05/03/2026, it had approved the appointment of Shreni Shares Limited as the Market Maker and had taken note of the resignation of MNM Stock Broking Private Limited as the Market Maker for the equity shares of the Company listed on the NSE EMERGE Platform with effect from 09/03/2026.

In order to ensure smooth transition and completion of necessary procedural formalities relating to the resignation of the existing Market Maker and appointment of the new Market Maker, the Board of Directors at its meeting held today has decided that the earlier decision of the Board dated 05/03/2026 shall stand modified and superseded to the extent of the effective timing of the change in Market Maker.

Accordingly, the Board has approved the following:

1. Appointment of Shreni Shares Limited as the Market Maker for the equity shares of the Company listed on the NSE EMERGE Platform with effect from the opening market hours of 10/03/2026, subject to the approval of the Stock Exchange and execution of necessary agreements.
2. The resignation of MNM Stock Broking Private Limited as the Market Maker for the equity shares of the Company listed on the NSE EMERGE Platform shall be effective from the closing market hours of 09/03/2026.

The Board has also approved the execution of a Market Making Agreement between the Company, Shreni Shares Limited and Interactive Financial Services Limited, in accordance with the applicable rules and regulations of the exchange.

Detailed information as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024, in respect of the aforesaid Agreement are provided in the attached Annexure A.
