**Subject- Non- Applicability of Regulation 23(9) as per Regulation 15 of Chapter IV of Securities and Exchange Board of India (Listing Obligations and Disclosures Requirements) Regulations, 2015 for the half year ended 30<sup>th</sup> September, 2025.**

Dear Sir/Madam,

In terms of the requirement of Regulation 23(9) of the SEBI (Listing Obligations and Disclosure Requirement), 2015, the listed entity shall submit such disclosures every six months on the date of publication of its standalone and consolidated financial results. However, in terms of Regulation 15(2) of SEBI (Listing Obligation & Disclosure Requirement) Regulation, 2015 the requirement of filing of Related Party Transactions as prescribed under Regulation 23(9) of said regulations for the Half Year ended 30<sup>th</sup> September, 2025 is not applicable to our Company.

Relevant text of the provisions of Regulation 15(2) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 is reproduced herein below for your kind reference.

*Regulation 15(2) The compliance with the corporate governance provisions as specified in regulations 17, 59[17A,] 18, 19, 20, 21,22, 23, 24, 60[24A,] 25, 26, 27 and clauses (b) to (i) [and (t)] of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V shall not apply, in respect of –*

*(b)[a] listed entity which has listed its specified securities on the SME Exchange, further to inform that the Company is listed on SME exchange.*

Considering the relaxation provided to SME Listed Companies, the provisions related to filing of Related Party Transactions for the Half Year ended 30<sup>th</sup> September, 2025 is not applicable on our Company.

Further, it is certified that whenever this regulation is applicable on the Company at a later date, we will comply with the requirements of the same within prescribed limit.
