## Press Release: Update on Legal Action

### Company Statement

Kay Cee Energy & Infra Limited has initiated both civil and criminal defamation cases. The company aims to safeguard its hard-earned reputation, market position, and stakeholder trust following recent malicious activities by certain parties.

### Details of Legal Proceedings and Defendants

- On **August 5, 2025**, **Mr. Rakesh Sharma**, resident of *Plot No. 81, 82, Abhinav Vihar Colony, Gandhi Path West, Lalarpura, Opposite Surya Residency, Jaipur-302001*, allegedly submitted false and defamatory complaints to *Rajasthan Rajya Vidyut Prasaran Nigam Limited*, accusing the company of fraud and irregularities without any supporting evidence.
- Subsequently, defamatory articles were published in ***Jansevak Newspaper***, operated from *Darbar Colony, Beawar Road, Opposite Indra Manch, Bijay Nagar, District Beawar*, under the editorial leadership of **Mr. Umesh Kumar**, resident of *195G, Gaushala Road, Sri Ganganagar (Rajasthan)* and second address at *Vidhan Sabha Road, Satya Vihar, Indrapuri, Vidhayak Nagar, Lal Kothi, Jaipur*.

### Relief Sought

The company has requested the court for:

- **Interim Injunction:** Prevention of further defamatory public statements, complaints, or publications about the company, directly or indirectly, during the legal process.
- **Permanent Injunction & Compensation:** Damages totalling ₹5 crores for reputational harm and financial loss, as well as reimbursement of legal costs.

Affidavits and evidence submitted by the company demonstrate the baselessness and damaging impact of the allegations and news reports on its business, employees, and financial standing.

### Additional Legal Actions:

The company is also in the process of filing cases against **Zee Rajasthan News Channel** and **Vertent Samachar Plus 24x7 News Channel** with cases expected to be filed within this week for spreading defamatory and misleading content that has further impacted the company's reputation.
