# Press Release: Update on Legal Action

# **Company Statement**

Kay Cee Energy & Infra Limited., a company registered under the Companies Act, 2013 (CIN. No. U74900RJ2015PLCO46976), has been engaged in Engineering, Procurement, and Construction (EPC) work since 2015. With a track record of executing over 500 projects—including major contracts exceeding ₹400 crore. The company has earned a strong reputation in infrastructure development, especially in high-voltage transmission lines (132 kV to 765 kV) for both central and state government agencies.

- 2. A **permanent injunction** to restrain the Defendants and their agents from publishing or circulating any further defamatory statements.
- 3. A public retraction and correction of the false information, published in the same or equivalent media channels.
- 4. Legal costs and expenses associated with this litigation.
