**Subject: Clarification regarding misleading news published in “Dainik Jansevak Samachar” dated 25.08.2025**

Dear Sir,

This is with reference to the news item published in “*Dainik Jansevak Samachar*” dated 25th August 2025, wherein it has been alleged that our Company, **M/s Kay Cee Energy & Infra Ltd.**, has obtained tenders worth ₹500 Crores by submitting fake qualification certificates.

It has come to our attention that baseless, misleading, factually incorrect and defamatory allegations and statements are being circulated suggesting irregularities in the award of tenders to the Company. We place on record that these allegations are false, unfounded, and without basis, made with the sole intention of maligning the reputation of the Company and casting unwarranted aspersions on the integrity of competent Government authorities who duly evaluated, supervised, and certified the works in question.

Our Company categorically denies and strongly refuses these allegations and reiterates that it has always conducted its operations with absolute transparency, highest standards of integrity, and in strict compliance with all applicable statutory and regulatory requirements. All works awarded to us by Rajasthan Rajya Vidyut Prasaran Nigam Ltd. (**RVPN**) or any other Government authority have been secured solely on the basis of authentic documents, technical competence, and proven track record of past performance.

Every document submitted by us has been genuine, verifiable, and issued by the appropriate Government authorities after due scrutiny. We would like to clarify the following points:

1. **Allegation: Company obtained ₹500 Crore tenders using fake qualification certificates.**

**Clarification:** Our participation in tenders has always been strictly in accordance with law and prescribed procedure. Contracts are awarded only after thorough scrutiny of technical and financial criteria, and the lowest eligible bidder is selected. Upon completion of work, completion certificates are issued by the competent authority after due verification. These certificates constitute the basis for eligibility in subsequent tenders.

All qualification certificates submitted by our Company are 100% genuine, and duly verified from the issuing authority. No document submitted by us has ever been fake or fabricated. Any allegation to the contrary is frivolous, defamatory, and mischievously intended to cast aspersions on our Company.

2. **Allegation: During the tenure of the previous Congress government, ₹300 Crore works were obtained, and during the present BJP government, ₹200 Crore works were obtained on the basis of forged certificates.**

**Clarification:** Our Company’s operations are not dependent on any political dispensation and are entirely apolitical. Works are awarded under infrastructure schemes of the Government through a transparent, competitive tendering process monitored by statutory authorities. Contracts secured by us have been based solely on technical competence, financial eligibility, and past performance. The allegation that tenders were obtained by forgery, linked to political regimes, is entirely incorrect, misleading, and a deliberate attempt to sensationalize a baseless claim

3. **Allegation: Fictitious figures were used to create eligibility documents.**

**Clarification:** This allegation is wholly untrue and devoid of any merit. All technical data, figures, and project details submitted by our Company are supported by authentic documents and completion certificates issued by Government authorities.

By way of example, Wonder Cement Limited. initially awarded us line work of 6.220 km, subsequently extended to 11.4 km with due approvals and sanctions by RVPN. The final line length was measured, certified, and recorded by RVPN itself. Completion certificates issued by RVPN authorities conclusively confirm the same. At no stage were fictitious or manipulated figures submitted by us.

4. **Allegation: Fraud was committed to secure crores worth of tenders.**

**Clarification:** This allegation is not only false but highly defamatory. The works in question were executed under direct supervision of RVPN, with Wonder Cement Limited, depositing 5% supervision charges directly with RVPN. Completion certificates were issued by RVPN authorities, being the owners and end-users of the works. The certificates submitted by our Company are the very certificates issued by RVPN, which have already been verified by Nigam with no irregularities found. The final line length reflected in the certificates was based on RVPN's own measurement, not ours. The project was completed over six years ago, after due verification by RVPN at the relevant time. Raising such allegations now is clearly malicious, misleading and unjustified.

Our Company has consistently conducted its business with utmost integrity, transparency, and strict adherence to law. Allegations of fraud, forgery, or fabrication are categorically denied as false, defamatory, and maliciously intended to cause reputational harm. We request the concerned authorities, stakeholders and public not to be misguided by such unverified reports.

**The Company has made genuine efforts to contact the news agency responsible for publishing such content; however, no valid contact details of the concerned individual could be ascertained. Notwithstanding this, the Company is actively exploring and initiating appropriate legal remedies against the publication of false and defamatory news intended to damage its reputation. The Company shall hold the concerned parties strictly liable for the circulation of such misleading and malicious content and will take all necessary steps under applicable law to safeguard its interests, including the initiation of legal proceedings once the responsible party is identified.**

We assure all our clients and partners that M/s Kay Cee Energy & Infra Limited. will continue to work with the same dedication, quality, and integrity as always. We reserve all our legal rights, including initiation of appropriate civil and criminal proceedings, against those responsible for propagating such baseless and malicious allegations.
