Sub: Intimation under Regulation 30(4) of SEBI (LODR) Regulations, 2015 – Final Exit from EOU Scheme

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Point No. 7 of Part B of Schedule III, we wish to inform you that M/s KIOCL Limited has received the Final Exit Order dated 07th August 2025 from the Office of the Development Commissioner, Cochin Special Economic Zone (CSEZ), approving the Company's exit from the 100% Export Oriented Unit (EOU) Scheme.

The approval has been granted subject to compliance with the standard conditions stipulated under Para 6.17 of the Foreign Trade Policy 2023, including settlement of applicable customs/excise duties and taxes, execution of legal undertakings, and other statutory requirements. Consequently, the Letter of Permission No. CIL:269(82) dated 03rd September 1982 (as extended) and the Green Card issued under the EOU Scheme stand cancelled with effect from the date of the order.

A copy of the Final Exit Order issued by the Office of the Development Commissioner, CSEZ, is enclosed herewith as **Annexure-I** for your records.

This disclosure is being made in accordance with the guidelines for determination of materiality as approved by the Board of Directors under Regulation 30(4) of the SEBI (LODR) Regulations, 2015.

FINAL EXIT ORDER

Whereas M/s KIOCL Limited, an EOU, located at Panambur, Mangaluru, Dakshina Kannada, Karnataka-575 010, were granted approval under EOU Scheme vide Letter of Permission No.CIL:269(82) dated 03/09/1982 (as extended) for the manufacture and export of Iron Ore Pellets. The Unit commenced its operation on 01/10/1981 and their LoP is valid up to 30.08.2027.

2. Whereas the said M/s KIOCL Limited, 100% EOU Mangalore had applied for exit from the EOU scheme to this office and in-principle approval was granted to them vide this office letter dated 02.07.2025. This final exit letter is issued by this office subject to compliance of standard conditions as per the provisions under Para 6.17 of FTP 2023 which stipulate the following:-

- a) Applicable Customs and Excise duties and/or taxes and compensation cess would be paid on the imported and indigenous capital goods, raw materials, components, consumables spares and finished goods in stock. The unit may be allowed to dispose of raw material, components, consumables etc. against duty free licenses. The unit may also be permitted to export the CG, raw materials/components etc.
- b) The penalty imposed by the appropriate authority, under the Foreign Trade (Development and Regulation) Act, 1992 for non-fulfilment of the conditions of approval, would be paid. In case an appeal against an order imposing penalty is pending, final exit would be considered if the unit has obtained a stay order from Competent Authority and has furnished a bank guarantee for the penalty adjudicated by the appropriate authority unless the appellate authority makes a specific order exempting the unit from this requirement.
- c) In case the unit has failed to fulfil the terms and conditions of LOP and penal proceedings are to be taken up/are in process, a legal undertaking for payment of penalties that may be imposed, would be executed with the Development Commissioner concerned.
- d) In case the EOU wishes to continue the operations in the DTA would need to comply with industrial, locational, environmental or other laws, rules and regulations in force for DTA units.

3. Whereas the Assistant Commissioner of Customs, EP Cell, Mangaluru vide their letter No.CUS/EPF/11/2025-EPC-O/o-Commr-Cus-Mangaluru dated 04/08/2025 (Digitally signed), has certified that there are 4 cases of confirmed demands involving amount of Rs.36.95 Crore pending in various appellate fora against the M/s KIOCL Limited.

4. And whereas the said M/s KIOCL Limited, has executed a Legal Undertaking with office of the Development Commissioner, Cochin Special Economic Zone, Cochin for payment of penalties as may be imposed upon them under Foreign Trade (Development and Regulation) Act, 1992, in the proper proforma prescribed by the Ministry of Commerce and also submitted the application for exit from EOU in Appendix ANF-6D.

5. Whereas no penal action is pending/contemplated against the said unit, M/s KIOCL Limited, 100% EOU Mangaluru, it is hereby allowed final exit of their Unit from EoU Scheme, approved vide Letter of Permission No. CIL:269(82) dated 03/09/1982 (as extended) and Green Card issued under EoU scheme are hereby cancelled from the date of issue of this order.

6. This is issued with the approval of the Development Commissioner, CSEZ.
