Note 1- Till the quarter ended September 30, 2025, the Company received proceeds of Rs 398.88 crore from the issue upon allotment and conversion of fully convertible warrants. Out of the received proceeds, Rs 396.25 crore has been utilized towards the objects of the issue and remaining Rs 2.63 crore is lying as a balance in preferential issue account of the Company and deployed in Fixed Deposit. Remaining amount of Rs 93.14 crore is expected to be received from the warrant holders. As per the notice to shareholders dated August 29, 2024, the warrant holders have the option to convert the warrants into equity shares within 18 months from the date of allotment of the share warrants.
