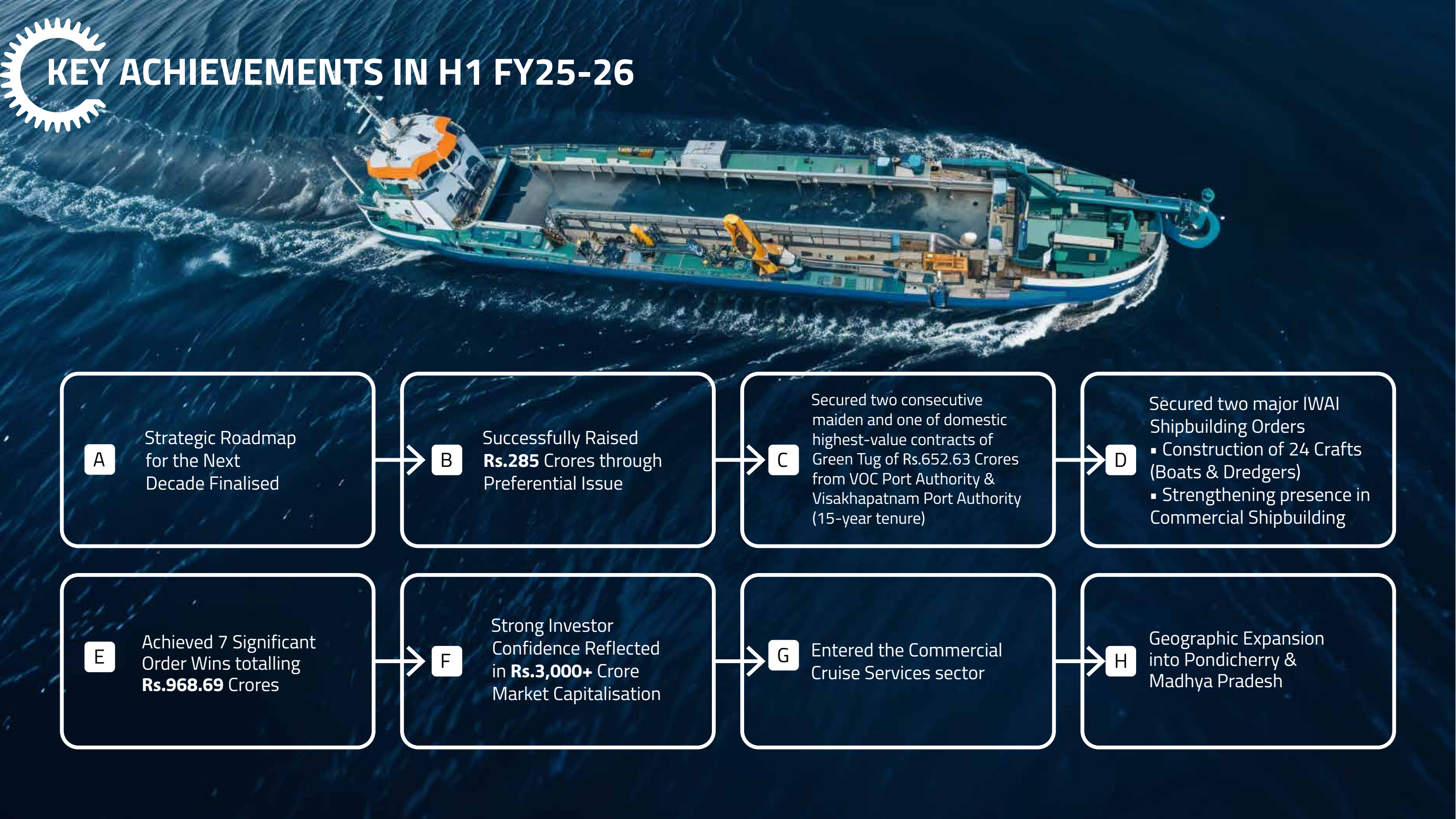
In FY 2025-26, the Company accelerated its forward and backward vertical expansion:

KMEW has an extensive experience in rock dredging works. The company operates robust Grab and Backhoe Dredgers supported by a fleet of well-equipped barges, buckets, chisels etc for rock-dredging and disposal.

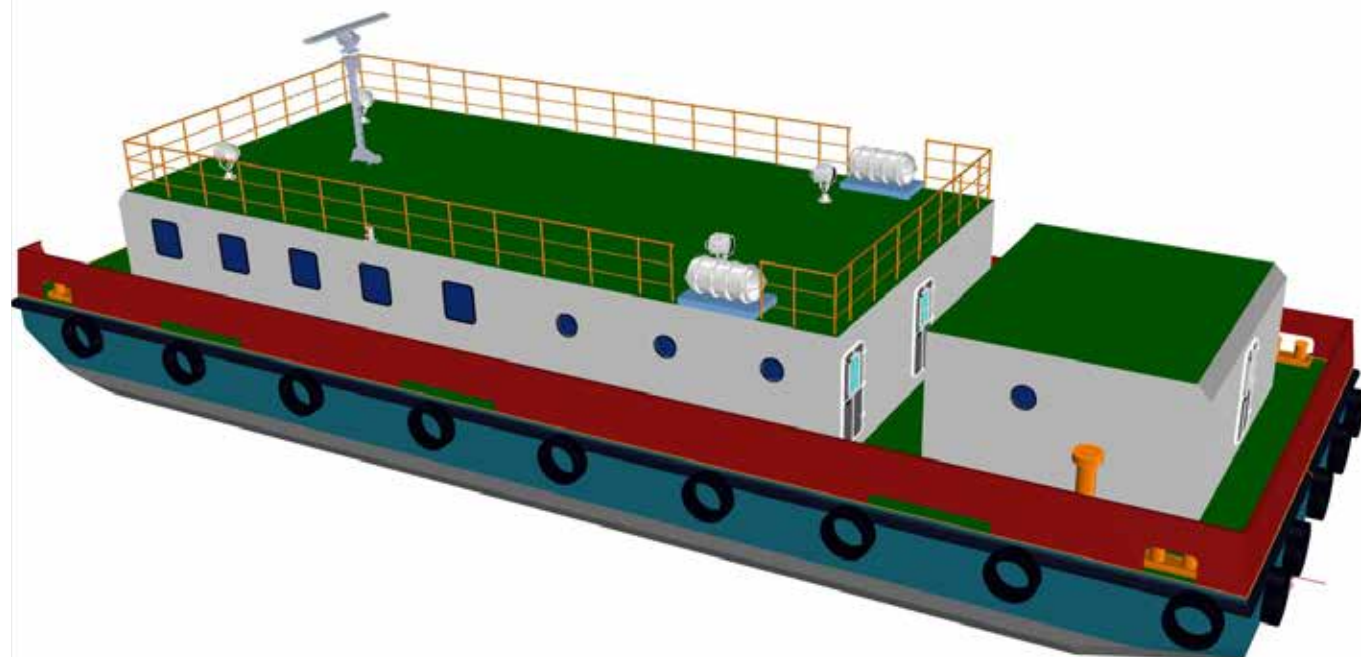

SHIP BUILDING EXPERTIES WITH ORDERS IN HAND

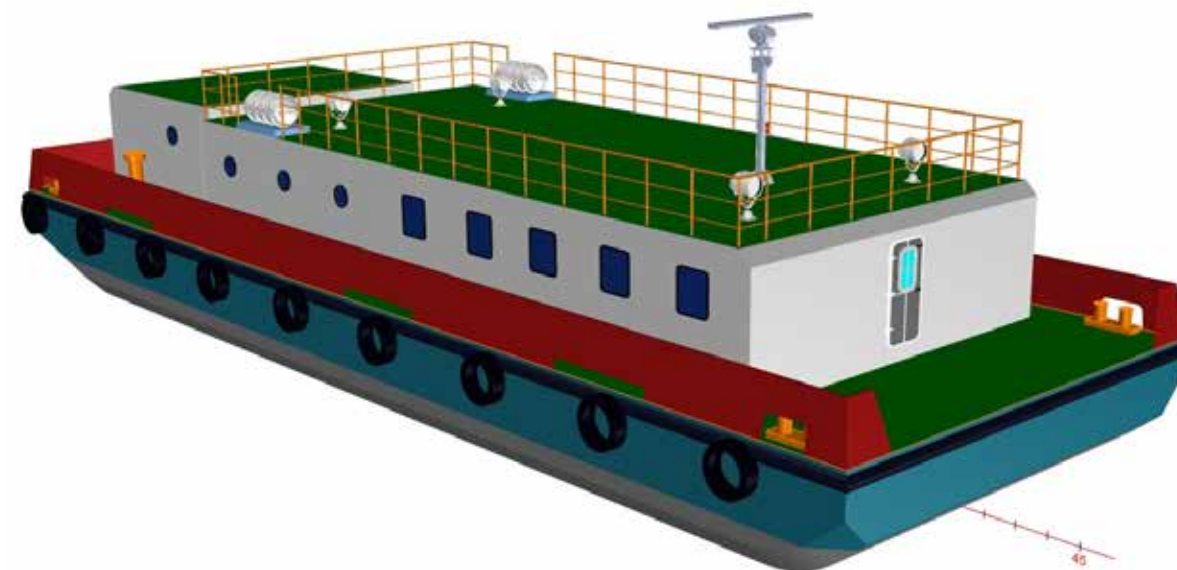
Inland Waterway Authority of India (IWAI) requires Dredgers and its ancillary crafts to support operations across National Waterways (NWs), with domestic shipbuilding. KMEW has been awarded two orders (value Rs.195 Cr.) & committed to design, construct and supply in India.

- **Procurement of Dredger Ancillary Units** (6-Work Boats +6-Accommodation Boats)
- **Procurement of 4 no .of Cutter Suction Dredger and 8 no. of Ancillary Units** (4-Work Boats + 4-Accommodation Boats)



These orders carry a delivery timeline of 14–24 months, followed by crew training for IWAI, along with manning and maintenance support.

- Shipbuilding at “Knowledge Shipyard Pvt. Ltd.” (KSPL), Mumbai.
- A total of 24 vessels are planned to be designed and constructed at KSPL in India under Atma Nirbhar Bharat initiative.
- KMEW has an experienced workforce for Design, shipbuilding, ship repair, and maintenance.

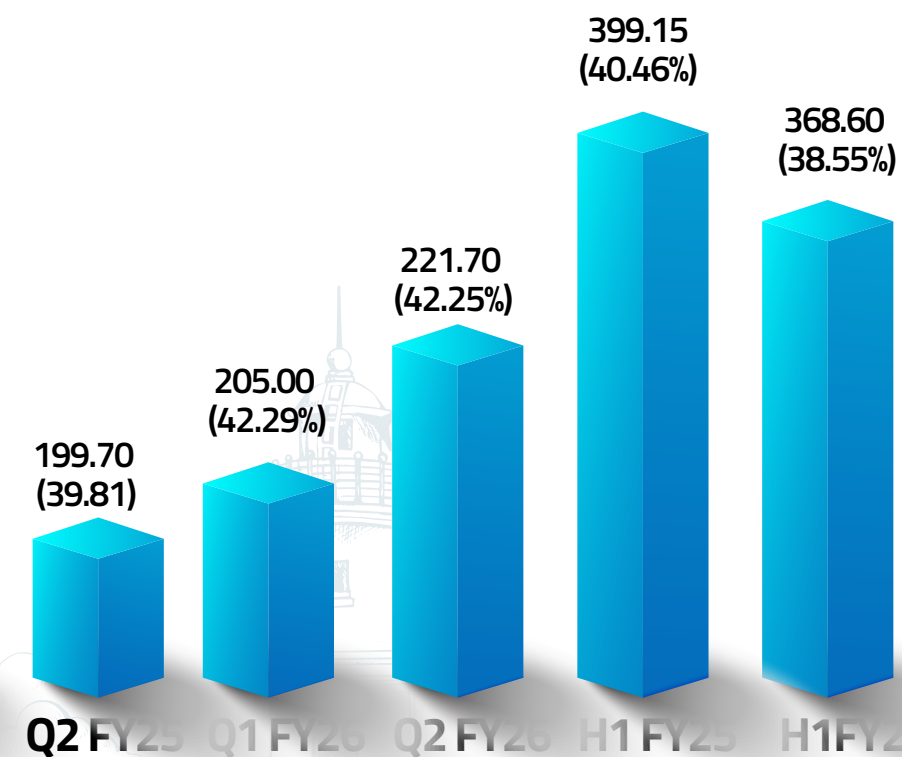
REVENUE FROM OPERATIONS (MN)



NET PROFIT (MN)

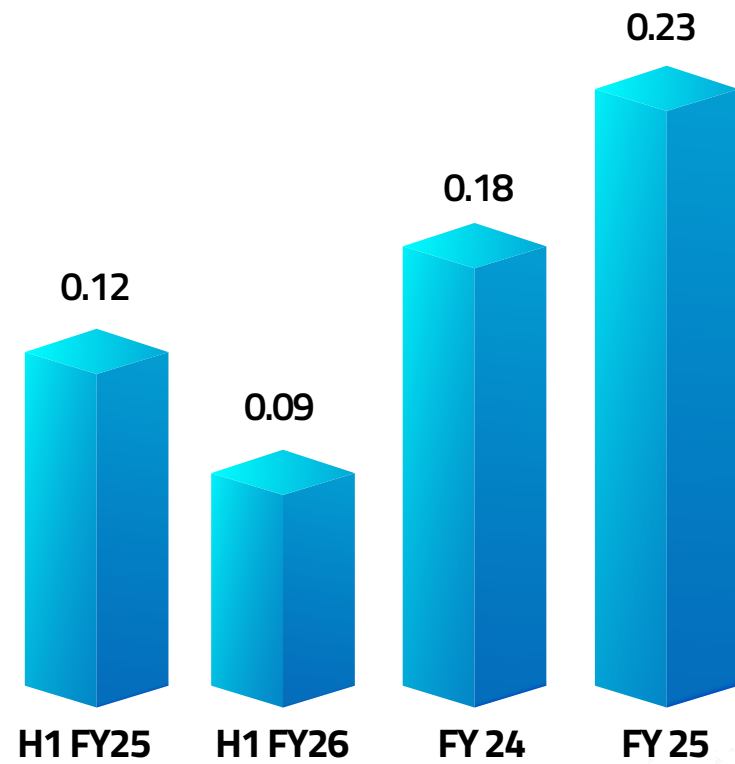

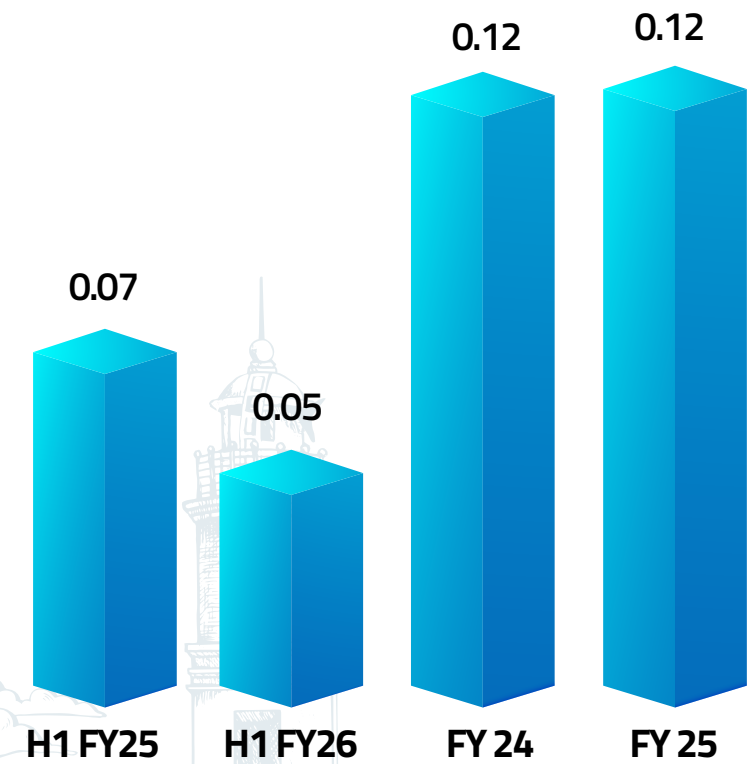
