## Clarification

**Hyderabad, January 14, 2016:** This is with regards to Notice issued by Public Works Department, Government of Arunachal Pradesh which debars M/s JKM Infra Projects Limited along with its JV partner, KNR Constructions Limited for a period of 6 months from participating in any tender of the State of Arunachal Pradesh and any State of the country including tenders of MORTH/NHAI/NHIDCL/BRO.
