Subject: Intimation under Regulation 30 of SEBI (LODR) Regulations, 2015

Ref: Our intimation dated 17th February 2026

We refer to the above captioned subject; in continuation to our intimation dated 17th February 2026 regarding receipt of letter of award for Construction of Four Lane Elevated Corridor along East Coast Road (ECR) from design Chainage Km. 11+480 to Km. 11/800 (West Avenue Road) and upto Km. 24+780 (East Coast Road) Thiruvanmiyur to Uthandi in SH-49 on Hybrid Annuity Mode (HAM) in the State of Tamil Nadu from Tamil Nadu State Highways Authority (TANSHA), we herewith intimate to you about the details of the case and order passed by the Hon'ble High Court of Madras in W.A. No 284 of 2026 as under:

- A) The Appellant (M/s Dilip Buildcon Limited) had approached the Hon'ble High Court of Madras, seeking correctness and validity of the rejection of their technical bid of the aforementioned project, by filing Writ Appeal (W.A No. 284 of 2026) before the Hon'ble High Court of Madras, to which the Company was made as one of the parties as Respondent along with the State of Tamil Nadu, The Chairman - TANSHA and The Tender Inviting Authority/ The Member Technical, TANSHA.
- B) The Hon'ble High Court of Madras heard the case on dated 16th February 2026 and uploaded the judgement on 18th February 2026, by stating that even though the learned counsel for the Appellant would strenuously urge this Writ Appellate Court to examine the correctness and validity of the reasons for rejection, the Hon'ble High Court of Madras is of the view that this aspect needs to be examined first by the Appellate Authority under Section 11 of the Tamil Nadu Transparency in Tenders Act, 1998. before it is brought to the Writ Court.
- C) Therefore, under that circumstances, the appeal was disposed by the Hon'ble High Court of Madras, giving the Appellant liberty to file appeal before the competent statutory authority within five days from 16th February 2026 and as statutorily mandated the Appellate Authority shall take a decision one way or the other within a period of 15 days from the date of submission of the appeal.
- D) Consequently, the interim application stands closed.
