Consequent to our intimation dated October 3, 2024 and 29<sup>th</sup> October 2024, we wish to inform you that KNRC Holdings and Investments Private Limited, (hereinafter referred to as KHIPL) Wholly owned subsidiary of the Company has transferred its entire shareholding in KNR Muzaffarpur Holdings Private Limited (hereinafter referred to as KMHPL), Step Down Subsidiary of the Company, to Mr. Gaurav Jalan (Promoter and Director of JKM Infra Projects Limited) pursuant to the share purchase agreement entered on 29<sup>th</sup> October 2024 for transfer of its entire stake i.e. 100% in KMHPL to JKM Infra Projects Limited and/or Mr Gaurav Jalan (Promotor and Director of JKM Infra Projects Limited) (the “Investor”)

The KHIPL has invested Rs 1.00 lakh (in form of equity) against which KHIPL has received Rs. 1.00 lakh through this transaction. As a result, KMHPL ceased to be subsidiary of KHIPL (wholly owned subsidiary of the Company) and step down subsidiary of the Company.
