Dear Sir/Madam,

This is in continuation of our letter dated June 18, 2026, intimating the convening of the Extra-Ordinary General Meeting ("EGM") of the Company scheduled to be held on Friday, July 10, 2026 at 01:00 P.M. (IST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM"). Pursuant to Regulation 28(1) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), the Company had submitted an application to the National Stock Exchange of India Limited ("NSE") seeking in-principle approval for the proposed preferential issue of equity shares, as set out in Item No. 1 of the EGM Notice read with the Explanatory Statement annexed thereto.

Subsequently, NSE, vide its letter bearing reference NSE/LIST/55849 dated June 25, 2026, advised the Company to incorporate certain clarifications and additional disclosures in relation to the proposed preferential issue by issuing a corrigendum to the EGM Notice.

Accordingly, please find enclosed the Corrigendum to the EGM Notice dated June 18, 2026, which shall form an integral part of the said EGM Notice and should be read in conjunction therewith.

In compliance with the applicable provisions of the Companies Act, 2013, the SEBI Listing Regulations, and the relevant circulars issued by the Ministry of Corporate Affairs ("MCA") and the Securities and Exchange Board of India ("SEBI"), the Corrigendum is being circulated only through electronic mode to those Members whose e-mail addresses are registered with the Company or the Depositories.

CORRIGENDUM TO THE NOTICE OF THE EXTRAORDINARY GENERAL MEETING ("EGM")

This Corrigendum is being issued in continuation of the Notice dated **18th June, 2026** ("Notice") convening the Extraordinary General Meeting ("EGM") of the Members of **Kontor Space Limited** ("Company"), scheduled to be held on **Friday, 10th July, 2026 at 01:00 P.M. (IST)** through **Two-Way Video Conferencing ("VC")/Other Audio-Visual Means ("OAVM")**.

The Notice of the EGM was duly dispatched to the Members of the Company on **18th June, 2026** through electronic mode, in compliance with the provisions of the Companies Act, 2013, read with the rules framed thereunder, applicable circulars issued by the Ministry of Corporate Affairs ("MCA") and the Securities and Exchange Board of India ("SEBI"), for transacting the business set out therein.

Subsequent to the dispatch of the Notice, the Company received certain observations from the National Stock Exchange of India Limited vide its letter bearing Ref. No. **NSE/LIST/55849 dated 25th June, 2026**. Accordingly, this Corrigendum is being issued to incorporate the following clarifications/modifications in the Explanatory Statement forming part of the Notice:

1. Shareholding-Pattern:

The shareholding pattern annexed to the Explanatory Statement was based on the shareholding as on **31st March, 2026**. Pursuant to the observations received from the National Stock Exchange of India Limited, the Company clarifies that there have been certain **minor changes** in the shareholding pattern between **31st March, 2026** and the date of dispatch of the Notice. Accordingly, the revised shareholding pattern before and after the proposed preferential issue is substituted in the Explanatory Statement.

2. Ultimate Beneficial Owner ("UBO"):

The details of the Ultimate Beneficial Owner of the proposed allottee **Arron Insurance Brokers Private Limited** were inadvertently omitted from the Notice. The same are hereby included in the revised disclosure forming part of the Explanatory Statement.

Except for the modifications and clarifications stated in this Corrigendum, **all other terms, contents and resolutions contained in the Notice of the EGM dated 18th June, 2026 shall remain unchanged and shall continue to be in full force and effect.**

This Corrigendum shall form an integral part of the Notice of the EGM and the Notice shall be read together with this Corrigendum.
