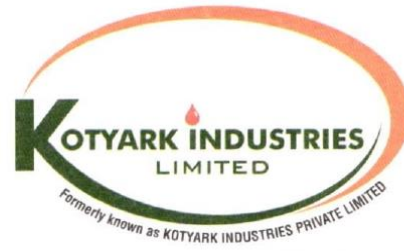

Subject: Disclosure under Regulation 30 of SEBI (LODR) Regulations, 2015-Update on Investigation Proceedings at Rajasthan Unit.

Dear Sir/Ma'am,

In continuation of our earlier intimation dated July 02, 2025, regarding the visit by Government officials at the Company's Rajasthan manufacturing facility, we wish to inform that a complaint was subsequently filed by Mr. Rajendra Kumar Sharma, Deputy CEO of the Bio-Fuel Authority, in relation to certain alleged non-compliances under regulatory provisions. The Company strongly denies the allegations.

It is pertinent to note that the Managing Director of the Company, Mr. Gaurang Rameshchandra Shah, has been operating the industry since 2019 under a valid registration granted by the Bio-Fuel Authority. The initial license/ registration certificate granted by the Bio-Fuel Authority, Government of Rajasthan, Jaipur under Rule 5.1 of the Rajasthan Bio Fuel Rules 2019 dated July 29, 2020 expired in July 2022 and the Company submitted a renewal application along with all requisite documents on July 06, 2022, well before expiry. Despite multiple submissions, clarifications, and full cooperation with the authorities over the last three years, no final decision has been made on the renewal. As a result, the Company filed two writ petitions before the Hon'ble High Court, outlining its repeated efforts and compliance with every request from the regulatory body.

We now wish to inform that the Hon'ble High Court of Jodhpur has granted interim relief in favour of Mr. Gaurang Rameshchandra Shah. The Court has directed him to cooperate with the ongoing inquiry and submit relevant documents. The Public Prosecutor has been instructed to obtain a status report within two weeks, and the matter is scheduled for hearing thereafter.

The Company reiterates that it has always operated in compliance with applicable laws and has proactively engaged with regulatory bodies. Stakeholders are advised to rely only on official communication from the Company or regulatory authorities.
