1 The above unaudited standalone / consolidated financial results for the quarter ended 31st December 2025 have been reviewed by the Audit committee and subsequently approved by the Board of Directors in their respective meetings held on 21st January 2026. These unaudited standalone / consolidated financial results have been subjected to limited review by the statutory auditors of the company. The statutory auditors have expressed an unmodified conclusion.
2 The above Standalone and Consolidated Financial Results have been prepared in accordance with the guidelines issued by the Securities and Exchange Board of India ("SEBI") and the Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act, 2013.
3 The Company has not elected to exercise its option permitted U/S 115BAA of the Income tax act, 1961* and provision of current tax has been made as per the normal provisions of the Income Tax Act, 1961* and rules there from under. Further current tax for the quarter ended 31st December 2025 has been provided based on Normal provisions of Income-Tax.
4 Other income includes net gain arising on sale of investment Rs. 101.63 and Rs. 203.67 Lacs for the nine month ended on 31st December 2025 and 31st December 2024 respectively and net gain arising on investments measured at FVTPL amounting Rs. 303.59 and Rs. 84.70 Lacs for the nine month ended on 31st December 2025 and 31st December 2024 respectively.
5 The Figures of previous quarter / year have been regrouped / reclassified, wherever necessary, to make them comparable.
6 On November 21, 2025, the Government of India notified the four Labour Codes - the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 (collectively "New Labour Codes") - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft Central Rules and FAQs to enable assessment of the financial impact due to changes in regulations. The company/group has assessed and disclosed the incremental impact of these changes on the basis of best information available and consistent with the guidance provided by the Institute of Chartered Accountants of India.
In accordance with the new Labour Codes, the Company has currently estimated the incremental impact on retirement benefits to be Rs. 243.20 lacs primarily arises due to change in wage definition. Considering the materiality and regulatory-driven, non-recurring nature of this impact, the company/group has presented such incremental impact as statutory impact of new Labour Codes and this has been presented under "Exceptional Items" in the standalone/consolidated results for the quarter & nine months ended December 31, 2025.
The code on Social Security 2020 ('Code') relating to employee benefits during the employment and post employment benefits received Presidential access in September 2020. The Code has been published in official budget in India. The effective date from which the Code is applicable and the rules to be frame under the Code are to be notified. The Company will assess the impact of the Code when it comes to effects and will record any related impact in the period of the Code become effective.
7 As per requirements of Regulation 33 of the SEBI (Listing obligation and disclosure requirements) Regulations, 2015, the Company is required to publish financial results. 
