**Scrutinizer's Report on postal ballot voting by way of remote voting by electronic means in respect of passing of the resolution set-out in the notice dated 28<sup>th</sup> October, 2024**

Dear Sir,

I, Urmil Ved, Company Secretary in Practice have been appointed as Scrutinizer by the Board of Directors of Kalpataru Projects International Limited (formerly known as Kalpataru Power Transmission Limited) ("**the Company**") for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process ("**e-voting**") in a fair and transparent manner on the resolution contained in the postal ballot notice dated 28<sup>th</sup> October, 2024 ("**Notice**") issued in accordance with General Circular Nos. 14/2020 dated 8<sup>th</sup> April, 2020, 17/2020 dated 13<sup>th</sup> April, 2020 read with other relevant circulars including 09/2023 dated 25<sup>th</sup> September, 2023 and 09/2024 dated 19<sup>th</sup> September, 2024 issued by Ministry of Corporate Affairs (MCA), Government of India (hereinafter referred to as "**MCA Circulars**"), Secretarial Standards on General Meetings (SS-2) issued by the Institute of Company Secretaries of India and other applicable laws, rules, regulations, to transact the special business as mentioned in the postal ballot notice.

The said appointment as Scrutinizer is under the provisions of Section 110 of the Companies Act, 2013 ("**the Act**") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended ("**the Rules**"). As the Scrutinizer, I have to scrutinize the process of e-voting conducted for the postal ballot, using an electronic voting system on the dates referred to in the Notice.

The Company has availed services of Central Depository Services (India) Limited ("CDSL") as the Service Provider for the purpose of extending the facility of remote e-voting to the members of the Company.

The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 ("LODR") relating to e-voting on the resolution contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

My responsibility as a scrutinizer for e-voting process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the members in respect of the resolution contained in the Notice. My report is based on verification of data and reports generated from the voting system provided by CDSL, the Service Provider.

The Notice dated 28<sup>th</sup> October, 2024 along with statement setting out material facts under Section 102 of the Act as confirmed by the Company were sent through electronic mode to those Members whose e-mail addresses were registered with the Company/Registrar & Transfer Agents/Depositories.





The Members of the Company as on the "cut-off" date as set out in the Notice i.e. Monday, 28<sup>th</sup> October, 2024 were entitled to vote on the resolution set out in the Notice.

The remote e-voting period remained open from Friday, 1<sup>st</sup> November, 2024 at 9:00 a.m. (IST) to Saturday, 30<sup>th</sup> November, 2024 at 5:00 p.m. (IST).

The votes cast during the remote e-voting were unblocked on Saturday, 30<sup>th</sup> November, 2024 after the conclusion of e-voting period for Postal Ballot and was witnessed by two witnesses, who are not in the employment of the Company and/or CDSL.

Thereafter, the details containing, inter alia, the list of Members who voted "in favour" or "against" on the resolution were generated from the remote e-voting website of CDSL, i.e., <https://www.evotingindia.com>. Based on the report generated by CDSL and relied upon by me, data regarding the remote e-voting was duly scrutinized.

I submit herewith the Scrutinizer's Report on the result of the remote e-voting for postal ballot, based on the report generated by CDSL and relied upon by me as under:
