So that what ever the consequence was happened was due to may be some technical issue during the final submission process led to there was a technical issue with the internal NSE systems or the XBRL filing utility, which resulted in the submission failure

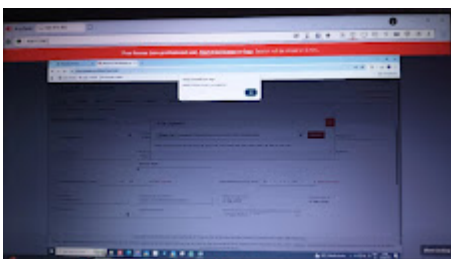


